

**SALIENT FEATURES OF THE RECRUITMENT PROCESS FOR APPOINTMENT  
TO THE POST OF STENOGRAPHER GRADE-II (PB.2. ₹ 9300-34800 + GRADE PAY ₹ 4200)  
(ADVERTISEMENT NO. 1/2014-R-III)**

(1)	Bhabha Atomic Research Centre, Trombay, Mumbai initiated recruitment process to fill up the vacancies in BARC and the Constituent Units of DAE located in Mumbai and Navi Mumbai for the post of Stenographer Grade.II in Group 'B' (Non-Gazetted) by Direct Recruitment. Accordingly, an abridged version of Advertisement No. 1/2014-R-III was released in Employment News (20 <sup>th</sup> December 2014) and other daily newspapers. The elaborate advertisement was also displayed on BARC website <a href="http://www.barc.gov.in">www.barc.gov.in</a> and <a href="http://www.barcrcruit.gov.in">www.barcrcruit.gov.in</a> with instructions to candidates to apply online. The last date for submission of online applications was 16.01.2015.																				
(2)	Nominations were also called for from Regional Employment Exchanges in terms of the extant rules and the website was made open upto 30.04.2015.																				
(3)	The website was also made open upto 30.04.2015 for enabling widows/divorced women and women separated from their husbands to apply in terms of extant rules.																				
(4)	To ascertain the genuineness of the candidates applied, the candidates were requested to submit a copy of their skill certificates (shorthand & typing) either online or offline. The last date for receipt of certificates was 31.08.2015. Thereafter, a provisional list of candidates based on the certificates submitted by them was uploaded with an instruction to report any discrepancy noticed latest by 31.12.2015. Consequently, this Centre received 06 representations & after ascertaining their genuineness, these candidates were also included in the eligible list of candidates.																				
(5)	A written examination of the eligible candidates was conducted on 05.03.2016, followed by Skill test (Stenography) on 06.03.2016 of the candidates who qualified the written examination.																				
(6)	Following the guidelines prescribed in DoPT OM No. 39020/01/2013-Estt(B) dated 09.10.2015, regarding discontinuing of interviews, interview which is a mode of selection for the post of Stenographer Gr.II was discontinued for this Advertisement.																				
(7)	Skill test results are based on these norms. As per rules, the maximum mistakes allowed in a transcript is : 10% mistakes for GEN & OBC candidates 15% mistakes for SC & ST candidates.
