FEE POLICY

ENROLLMENT FEE

This fee is payable upon acceptance of offer, it is a one-time and non-refundable payment.

- * For Elementary School students, enrollment fee is payable upon acceptance of offer;
- * For Middle & High School students, enrollment fee is payable only when the prospective students have passed the placements tests and have accepted the place offered by the school.

SCHOOL FEE

All fees must be paid by the due date as stated in the school's invoice. Students will not be allowed to attend classes if fees are not paid before classes commence.

Payments should be made payable to "ISS International School Pte. Ltd". Interest will be charged at 5% per month for all late payments for a period of up to two (2) months commencing from the day immediately after a payment falls due.

Tuition fees will be invoiced on a pro-rated basis if a new student enrolls and commences his / her studies after the beginning of a new semester. However, if the student decides to leave in the middle of the semester, refund will be based on the following refund policy.

Monies received by ISS will be applied in the order of Enrollment Fee, Tuition Fee, Stationery and other fees.
