# (Paper-I) Theory and Method of Historical Inquiry

Time: 3 hours (Total Marks: 100) 4 Credits Written Exam. 80 marks

Internal Assessment 20 marks

**Objective:** To familiarize the students with theories and methods of historical enquiry.

**Pedagogy**: To familiarize students with the intricacies of historical enquiry at least three lectures and five periods of discussion will be held on each Unit. The students will make a brief presentation on each UNIT.

### Instructions for paper setters and candidates:

There will be nine questions in all. The paper-setter is required to set two questions from each Unit. The candidate will be required to attempt 4 questions in all selecting one from each unit. All questions carry equal marks.

- 1) Paper 1 will be of 80 marks. 20 marks will be set aside for internal assessment.
- 2) Question No. 1 will be compulsory. It will consist of 8 questions. The candidate is required to attempt any **5 short answer type questions** in 80 to 100 words each. Each question carries 4 marks.
- 3) The paper setter will set 2 essay type questions from each UNIT. The candidate will attempt one question from each UNIT. Each question will carry 15 marks.

There will be eight questions in all. The paper-setter is required to set two questions from each Unit. The candidate will be required to attempt 4 questions in all selecting one from each unit. All questions carry equal marks.

#### **Unit-II**

Marxist Interpretation of Ancient Indian History: D.D. Koshambi and R.S. Sharma; Ideology of communalism.

### Instructions for paper setters and candidates:

The paper is of 100 marks. 50 for theory and 50 for presentations. There will be 9 questions in all. The candidate is required to attempt five. i) Question No. 1 will be of 10 marks. It will consist of 8 short answers type. The candidate is required to attempt any five short answer type in 40 to 50 words. Each question will carry 2 marks. ii) The paper setter will set two questions from each Unit. The candidate will attempt 4 questions taking one from each UNIT.

Introduction to the concepts of Qualitative and Quantitative Research Methods. Examination and analysis of both Primary and Secondary sources; Use of oral traditions, Private papers, Museum records and newspapers.

### **Unit-II**

Choice of a subject and rationale of a research problem Formulation of Research Questions and objectives, preparing tentative chapterization.

### **Unit-III**

Organization of Data Footnoting and Bibliography Proof reading and final draft

### **Unit-IV**

Introducing new tools for research: Use of Maps, diagrams tables, survey and graphs.
