FOR

M.PHIL PROGRAMME IN KANNADA

(Under Credit and Semester System w.e.f. 2016 Admission)

The M.Phil Programme in Kannada will be a fulltime Programme of one year duration with two Semesters of six months each. Each Semester shall have 450 contact hours distributed over a period of 15 weeks. A Masters Degree from Kannur University or from any other University recognized by Kannur University as equivalent thereto, with not less than 55% marks in the qualifying degree examination. However, for those belonging to SC/ST categories, a pass in the qualifying degree examination would suffice, for applying to the Programme and there will be a relaxation of 5% in marks for the teachers of the affiliated colleges.

SCHEME OF EXAMINATION

The Programme shall consist of two Core courses , One Specialization , Dissertation and Viva-Voce. First Semester Examination will be conducted at the end of the sixth month from the commencement of the programme. There will be two core courses(Papers) in the 1st Semester examination. In the second Semester, Area of Specialisation is focussed. Specialisation course is subjected only to Continuous Assessment comprising of four components carrying equal marks. Dissertation should be submitted at the end of the Second Semester. Viva - Voce will be conducted on the Dissertation. Both Dissertation and Viva – Voce would be subjected only to End Semester Assessment.

Continuous Evaluation for this course is based on the following activities by the students.

The course has 4 components:i) Assignment/research design, ii)Presentation of research design ,iii) Review Article, iv)Presentation of Review article -with equal weightage of 25 marks for each.

Framing a research design/ Assignment on one's chosen topic -25marks

Presentation of the same in a department seminar-25marks

Writing a review article based on an extended literature review pertaining to one's chosen topic -25 marks

Presenting the same in a Dept Seminar- 25 marks.

The student have to submit a copy of one's research design/assignment after due modifications based on the feedback received at the time of its presentation.

The End semester assessment for the 1ST Sem will be conducted by the Department.The concerned Faculty would prepare two sets of q.papers out of which one will be selected by an external examiner after due scrutiny.Each Q.paper would be set for 100 marks which would be converted to the respective weightage allocated for for ESA.The Chairman of Examinations HOD shall conduct the examinations.

Dissertation: The ESA for Dissertation will have two components namely Valuation of Dissertation and Viva –voce in the ratio of 75:25 respectively. Dissertation should be submitted at the end of the 2nd semester. The Dissertation which shall be approximately of 20000 words (Roughly about 100-120pages) including Bibliography, based on original Research in the area of specialization prepared under the supervision of faculty in the dept is to be submitted at the end of the second Sem for external evaluation and Viva –voce. Under exceptional circumstances the supervisor may recommend a student's request for extension of the submission of Dissertation for a period of not more than six months which may be approved by the H.O.D. Valuation of the Dissertation and the conduct of the Viva-voce will be carried out by a Board of Examiners comprising two members including the H.O.D and one External Examiner, nominated by the University from the Panel of Examiners , submitted by the H.O.D after due approval by the Department Council

The performance of the scholars in each course is indicated by the Grade point(GP) (with single decimal), Grade, and Credit Points(CP) while theperformance at the end of each Semis indicated by the Grade Point Average(GPA), which is calculated by taking the weighted average of the Grade Points

Successful completion of the .Programme : A separate minimum of C Grade in each of the Core Course is required for pass, while B grade is required for the completion of the Courses in each Semester and for the successful completion of the Programme.In the case of a candidate failing to secure the minimum requirement in the first Sem he/she could apply for reappearance of any of the course or for both the courses and improve the performance in the subsequent appearance in the ESE along with the next batch of students to overcome the deficiency. However, such deficiency would not deter a student in continuing the Course in the Second Sem and fulfilling all the requirements including the submission of the Dissertation.
