Result of 'Walk In Interview' for the post of JE (Civil) on contract basis for a period of 5 years

This is with reference to this office advertisement No. DMRC/PERS/22/HR/2012(39) dated 10.07.12. As a result of "Walk In Interview" held from 24.07.12 to 27.07.12, the following candidates have been found suitable for induction in DMRC for the post of JE (Civil) in the pay scale ₹ 13500 – 25520/- on contract basis for a period of 5 years. On being found medically fit, the candidates have to join **DMRC within 10 days period**. The result against reserved category post will be provisional and subject to the final outcome of the WRIT Petition No. 7878/2010 (Sarv Rural & Urban Welfare Vs UOI & others)

Character & Antecedents: The success in the examination does not confer any right to appointment unless the corporation is satisfied after such an inquiry, as may be considered necessary, that the candidate having regard to his/her character and antecedents is suitable in all respects for appointment to the service.

Surety Bond: The selected candidates will have to execute a surety bond of ₹ 75,000/- to serve the corporation for a minimum period of three years and also a three months prior notice, will be required before seeking resignation from the corporation.
