### ELIGIBILITY FOR ADMISSION

• Graduates and Post Graduates from any stream with 50% of marks

### For Direct admission to Semester II

• MBA / PG Diploma in Management from reputed Institutions

### For Direct admission to Semester III

• In addition to the qualification prescribed for semester II, the candidate should possess a GDMM/ PGDLM offered by IIMM or equivalent Post Graduate Courses with specialization in Materials Management/ Operations Management offered by other recognized institutions

#### **For Defence Personnel**

- Commissioned Officers of any branch / Corps.
- Non-commissioned Officers with 10 years of service.

NOTE: Defence Personnel with applicable qualifications as mentioned above, may get direct admission in Semester II or III on a par with others.

### **Exemption from specific subjects**

Exemptions from specific subjects may be offered to candidates who have earlier studied and passed an equivalent examination from any reputed institution, with 50% marks. Such candidates will however be required to join in Semester I and apply for exemption, separately, with all the supporting documents.

Decision of the Academic Council in all the matters of exemption will be final.

The exemption means that the student will not be required to submit the assignments for the exempted subjects. However, he/she will have to appear in the semester end examination and obtain 50% marks.

### NOTE:

- (a) Fees include: Tuition fee of Rs 6000/- and Administration fee of Rs 4000/- **per semester.**
- (b) Students living abroad (i) will be given examination online (ii) will receive the hard copy of study material at their postal address abroad (iii) Will attend the 'Virtual class sessions' in a selected location in their country, subject to availability of sufficient number of students.

(c) After the admission, if any student happens to move to a foreign country for any reason, he/she may opt to be an **'overseas student'** by paying the difference in the fees, as applicable.

# **Fees Concession for Defence Personnel**

Serving defence personnel and Ex-servicemen will be eligible for 20% concession in the applicable `COURSE FEE' only.

For example, if a defence personnel joins Semester I, he will pay Rs16,000/- as first instalment and Rs16,000/- as second instalment.

If he joins Semester II, directly, he will pay Rs8,000/- as first instalment and Rs16,000/- as second instalment.

However, defence personnel are not given any concession in the examination fees.

## **Enclosures to application form:**

- 1. Passport size photograph 2; Stamp size 1 (for ID Card)
- Photocopies of all the Degree Certificates (In the absence of the Degree Certificate, send the Provisional Degree Certificate). The photocopies are to be self attested by the candidate. (Applications without Degree or Provisional Degree Certificate will be rejected)
- 3. Marks statements of the qualifying Degree.
- 4. Service certificate or experience certificate issued by the employer (for those employed).

Applications, deficient in any respect will be rejected. Hence, the applicants are advised to carefully read the Prospectus before sending the application.

On receipt of application for admission, CIL will scrutinise the same for eligibility and send the **'Provisional admission letter'**, advising the candidate to send the fees in the form of Demand Draft drawn in favour of **'Confederation of Indian Industry - SR'**, payable at CHENNAI.

If necessary, CIL will conduct admission test to screen the applications. This will be intimated to applicants.

### GENERAL INSTRUCTIONS

- The entire course banks upon distance mode. All students are entitled to get a copy of study material as and when the payment is made and the study material will be couriered or posted to the ADDRESS PROVIDED BY THE student in the application form. <u>ANY CHANGE IN ADDRESS</u> <u>SHOULD BE INTIMATED TO THE COURSE COORDINATOR</u> <u>IMMEDIATELY</u>.
- Apart from study material, students will also be provided e-tutorship. This will be the vital mode for exchange of information and clarification with

the Education Counsellors and preparation for the examination. <u>STUDENTS SHOULD PERIODICALLY CHECK EMAILS AND INTERACT</u> <u>THROUGH MAIL, AS THE COURSE WILL BE RUN ON E-MODE AND</u> <u>ADDITIONAL MATERIALS WILL BE SENT ONLY BY EMAIL.</u>

## E-TUTORSHIP AND VIDEO CDS

# Virtual Classes

Students will have to attend the classes in selected locations in India and abroad. List of locations will be circulated to students after admission.

# Examination

Students should necessarily register for all the papers of their current semester, for the first time. However, they may or may not appear in all the papers they registered for. Registration for appearing in the arrears papers of the previous semesters is optional. But, it should be noted that it is mandatory to pass all the papers and become eligible for the award of the PG Diploma within one year from the completion of the course. In other words, a student will be permitted to appear in two semester examinations only, after completion of the course, in order to pass all the subjects, prescribed for the course.
