Introduction

The Foundation Course on education of children with disabilities is a collaborative initiative of Indira Gandhi National Open University (IGNOU) and Rehabilitation Council of India (RCI), which is being offered through distance education designed for in-service teachers of mainstream Schools. Presently this Programme is being offered in English, and will soon be offered in Hindi as well as in other Regional Languages.

The Persons with Disability Act 1995 has a provision of providing education to children with disability in the most appropriate environment. The Sarva Shiksha Abhiyan launched by the Govt. of India underlines the prerogative of a child with disability to be included in the main system of education, however, all this cannot be achieved unless teachers are qualified to help such children and their parents. The Foundation Course has been developed to impart the basic understanding and competencies to the teachers of the mainstream school for dealing children with disabilities. It enables the teacher to imbibe knowledge, understanding, attitude and skills to impart education efficiently to children with disabilities. The efforts of the Sarva Shiksha Abhiyan 2000 to include all children including Children with Disabilities in regular schools will only succeed when all the teachers in regular education system are given competencies in dealing with special needs.

The course content of the Foundation Course endeavors to address the various issues and concerns related to children with disabilities in "Rights" based perspective, as the UN Convention on the Rights of Persons with Disabilities 2006 envisages persons with disabilities enjoy all "Human Rights" on an equal basis with others,

In order to realize the objectives, the programme is designed as a combination of print material-based learning and face-to-face contact sessions, which can be completed in a three-month period. Though the print material is self-instructional in nature, to enable the learners to understand the printed study material as well as to provide individualized guidance and practical training regarding carrying out the various activities with the children with disabilities, face-to-face training programme equivalent to 120 hours will be organized by the Programme Study Centres.

The efforts of National Centre for Disability Studies (NCDS) for developing such an innovative programme of a comprehensive nature within a short duration are indeed commendable. 1. INTRODUCTION

The Indira Gandhi National Open University was established by an Act of Parliament in 1985 to achieve the following objectives:

- democratizing higher education by taking it to the doorsteps of the learners
- providing access to high quality education to all those who seek it irrespective of age, region, religion and gender
- offering need-based academic programmes by giving professional and vocational orientation to the courses
- promoting and developing distance education in India
- setting and maintaining standards in distance education in the country as an apex body.

1.1 Prominent Features

- IGNOU has certain unique features such as:
- international jurisdiction
- flexible admission rules
- individualized study: flexibility in terms of place, pace and duration of study
- use of latest information and communication technologies
- nationwide student support services network
- cost-effective programmes
- modular approach to programmes
- resource sharing, collaboration and networking with conventional Universities, Open Universities and other Institutions/Organizations
- socially and academically relevant programmes based on students need analysis
- convergence of open and conventional education systems

1.2 Important Achievements

1.3 The Schools of Studies

With a view to develop interdisciplinary studies, the University operates through its Schools of Studies. Each School is headed by a Director who arranges to plan, supervise, develop and organize its academic programmes and courses in coordination with the School staff and different academic, administrative and service wings of the University. 1.4 Academic Programmes

The University offers both short-term and long-term programmes leading to Certificates, Diplomas and Degrees, which are conventional as well as innovative. Most of these programmes have been developed after an initial survey of the demand for such Programmes. They are launched with a view to fulfill the learner's needs for:

- certification.
- improvement of skills,

- acquisition of professional qualifications,
- continuing education and professional development at work place,
- self-enrichment,
- diversification and updation of knowledge, and
- empowerment.

1.5 Course Preparation

Learning material is specially prepared by teams of experts drawn from different Universities and specialized Institutions in the area spread throughout the country as well as in-house faculty. These materials are scrutinized by the content experts, supervised by the instructors/unit designers and edited by the language experts at IGNOU before they are finally sent for printing. Similarly, audio and video cassettes are produced in consultation with the course writers, in-house faculty and producers. The material is previewed and reviewed by the faculty as well as outside experts and edited/modified, wherever necessary, before they are finally dispatched to the students, Study Centres and Telecast through Gyan Darshan.

1.6 Credit System

The University follows the 'Credit System' for most of its programmes. Each credit in our system is equivalent to 30 hours of student study comprising all learning activities (i.e. reading and comprehending the print material, listening to audio, watching video, attending counseling sessions, teleconference and writing assignment responses). Thus, a 4-credit course involves 120 hours of study. This helps the learner to know the academic effort he/she has to put in, to successfully complete a course. Completion of an academic programme (Degree or Diploma) requires successful completion of the assignments, practicals projects and the term-end examination of each course in a programme.

1.7 Support Services

In order to provide individualized support to its learners, the University has a large number of Study Centres, spread throughout the country. These Study Centres are co-ordinated by 43 Regional Centres and Recognised Regional Centres. At the Study Centres, the learners interact with the Academic Counsellors and other learners, refer to books in the Library, watch/listen to video/audio programmes and interact with the Coordinator on administrative and academic matters. The list of Regional and Study Centres is given in this handbook. Support services are also provided through Work Centres, Programme Study Centres, Skill Development Centres and Special Study Centres.

1.8 Programme Delivery

The methodology of instruction in this University is different from that of the conventional Universities. The Open University system is more learner-oriented and the learner is an active participant in the pedagogical (teaching and learning) process. Most of the instructions are imparted through distance education methodology and face-to-face mode as per the requirement.

The University follows a multimedia approach for instruction, which comprises:

a) Self Instructional Written Material:- The printed study material (written in self-instructional style) for both theory and practical components of the programmes is supplied to the learners in batches of blocks for every course (on an average 1 block per credit). A block which comes in the form of a booklet usually comprises 3 to 5 units.

- b) Audio-Visual Material Aids:- The learning package contains audio and video CDs which have been produced by the University for better clarification and enhancement of understanding of the course material given to the learners. A video programme is normally of 25-30 minutes duration. The video cassettes are screened at the study centres during specific sessions which are duly notified for the benefit of the learners. The video programmes are telecast on National Network of Doordarshan and Gyan Darshan. All Gyan Vani stations are broadcasting curriculum based audio programmes. In addition, some selected stations of All India Radio are also broadcasting the audio programmes. Learners can confirm the dates for the programmes from their study centres. The information is also provided through the university website.
- c) Counselling Sessions:- Normally counselling sessions are held as per schedule drawn by the Study Centres. These are mostly held during the non-working hours of the host institutions where the study centres are located.
- d) Teleconferences:- Live teleconferencing sessions are conducted via satellite through interactive Gyan Darshan Channels as well as simulcasted on 'Edusat' channel from the University studios at EMPC, the schedule of which is made available at the study centres.
- e) Practical's/Project Work:- Some Programmes have practical/project component also. Practicals are held at designated institutions for which schedule is provided by the Study Centres. Attendance at practicals is compulsory. For project work, comprehensive project guide, in the form of a booklet, is provided to the student along with the study materials.

1.9 Evaluation System

The system of evaluation in IGNOU is also different from that of conventional universities. IGNOU has a multi-tire system of evaluation.

- 1. Self-assessment exercises within each unit of study.
- 2. Continuous evaluation mainly through assignments which are tutor-marked, practical assignments and seminar/ workshops/extended contact programmes.
- 3. The term-end examinations (TEE).
- 4. Project works

The evaluation of learners depends upon various instructional activities undertaken by them. A learner has to write assignment responses compulsorily before taking term-end examination from time to time to complete an academic programme. A learner has to submit Tutor Marked Assignments (TMA) responses to the Coordinator of the Study Centre concerned to which s/he is attached. A learner should keep duplicate copies of assignment responses of TMA that may be required to be produced at Student Evaluation Division (SED) Division on demand. Term-end examination is conducted at various examination centers spread all over the country and abroad in June and December.

IGNOU uses the following system of "Grading" for evaluating learner's achievement

For Bachelors' and Masters' degree programmes, normally the system of numerical marking is followed, and the marks secured in assignments, TEEs, etc. are later converted into grades as per the five-point grading scale given above. However, if required by the learner, the university provides numerical marks and division (I, II or Pass).

Term-end Examination and Payment of Examination Fee

The University conducts Term-end Examination thrice a year. For this programme the examination will be held on the last Sunday of December, April and August. Students will be permitted to appear in term-end examination subject to the conditions that registration for the courses, in which they wish to appear is valid, minimum time to pursue these courses is elapsed and they have also submitted the required number of assignment(s), if any, in those courses by the due date.

Students can also submit On-line examination form as per guidelines through IGNOU website at www.ignou.ac.in.

Examination fee of Rs.50/- is required to be paid either through online payment gateway, cash deposit on designated banks and also through demand drafts.

2. REHABILITATION COUNCIL OF INDIA

Rehabilitation Council of India is a Statutory Body of Ministry of Social Justice & Empowerment, set up by an act of Parliament in 1992 and charged with the responsibility of planning, developing, and standardizing the quality of training for sixteen categories of Rehabilitation professionals under its purview to meet the needs of the life span of persons with disabilities. This Act was further amended in the year 2001 to widen the responsibilities of the Council to include:

- **Standardization** of training courses for professional/personnel's needed for the special education or rehabilitation of persons with disabilities.
- Regulation of training policies, programmes and standards in the field of Special Education and Rehabilitation.
- Recognition and Monitoring of Institutions/Organizations/Universities offering courses for training of rehabilitation professionals.
- Maintenance of a Central Rehabilitation Register (CRR) of all qualified persons in the field of Special Education and Rehabilitation.

Under section 13 of the RCI Act, no persons, other than the rehabilitation professionals/personnel who posses a recognized rehabilitation qualification and is enrolled on the Central Rehabilitation Register (CRR):

- 1. Shall hold office as rehabilitation professional or any such office (by whatever designation called) in Government or in any institution maintained by a local or other authority.
- 2. Shall practice as rehabilitation professional anywhere in India
- 3. Shall be entitled to sign or authenticate any certificate required by any law to be signed or authenticated by a rehabilitation professional;
- 4. Shall be entitled to give an evidence in any court as an expert under Section 45 of the Indian Evidence Act, 1872 on any matter relating to the handicapped:

The Act further states that those who act in contravention of any provision of subsection (2) cited above shall be punished with imprisonment for a term which may extend to one year or with fine which may extend to one thousand rupees, or with both.

In implementing its responsibilities, over the last decade and more, the **Rehabilitation Council of India** has played a crucial role **in offering a better quality of life for persons with disabilities**. The Council has developed numerous need based training programmes for special education and rehabilitation of persons with disabilities. Further, RCI realized that in order to meet the huge need for trained manpower in the area of special education in the country, the most viable option was through the distance mode of education, because of its flexibility and wide coverage, and thus extended the range of delivery of training by offering distance education courses.

Distance Education in itself is a growing field, as it offers the option of self study at the doorstep of the student, along with the support and guidance of trained faculty at the Study Centres close to home. It allows the student trainees flexibility of study hours and enables them to continue to work and study at the same time. Moreover the system of distance education has the potential to fulfill the enormous responsibility of *universalization and democratization of education*, as it holds the promise of checking the falling standards at reasonable costs, making the optimum use of media and technology and providing education relevant to the needs of the country.

The Rehabilitation Council of India visualizing the benefits of distance education in the area of disability rehabilitation and its potential for preparing professionals in the field of Special Education began to collaborate with Open Universities to promote and implement Special Education training programmes for the empowerment of a special target group of learners with disabilities.

MoU between RCI & IGNOU

IGNOU is offering need-based Special Education Programmes through Distance Education Mode in collaboration with Rehabilitation Council of India (RCI) within the framework of the Memorandum of Understanding (MoU) signed between the two on September, 2007. Under the provision of MoU, IGNOU has been recognized as the apex National Resource Centre for Special Education and Rehabilitation programmes through Distance Mode.

IGNOU will collaborate with RCI in design and development of Special Education and Rehabilitation programmes through Multimedia Distance Mode and will also facilitate delivery and certification of such programmes.

3. NATIONAL CENTRE FOR DISABILITY STUDIES

In order to achieve the goal of universalisation of education and also higher education (i.e., teaching, training, research, extension and good governance, as specified by the <u>IGNOU Statute</u>,), the **National Centre for Disability Studies** was established to undertake plethora of academic, research, extension and awareness activities for empowering the persons with disabilities and create a society that is friendly for them.

The National Centre for Disability Studies has been set up with the following broad objectives:

- 1. To offer academic and research programmes through distance mode of learning on multitudinous aspects of disability with interdisciplinary perspectives;
- 2. To develop human and material resources for promotion of teaching and research in Disability Studies and allied areas;
- 3. To facilitate empowerment of the persons with disabilities by promoting capacity building, entrepreneurship development and vocational rehabilitation services;
- 4. To Serve as a repository of official publications and documents of Government of India, State Governments and other governmental and non-governmental (national, regional and international) organizations / agencies;

- To organize conferences, seminars, symposia and training workshops at national, regional and international levels on issues of contemporary significance for persons with disabilities and people who matter to them;
- 6. To publish monographs, journals, occasional papers, research studies, teaching and self instructional materials as well as an Indian encyclopedia on diverse aspects of Disability;
- 7. To promote and co-ordinate the teaching, research and extension programs on Disability in the universities, national institutes and academic institutions of higher education within India and in neighboring SAARC countries;

4. SOME SALIENT FEATURES OF THE FOUNDATION COURSE

This Programme aims to develop basic competencies, knowledge, understanding, attitudes and skills in teachers and enable them to cater to the specific educational needs of children with disabilities in regular classes. The teachers play a significant role in the formative years of a child and their empowerment will enable them to imbibe knowledge, understanding, attitudes and skills to impart education efficiently to children with various disabilities.

Moreover, this Foundation Course will serve as an **Introductory Programme** to those learners who are interested to develop professional expertise in the field of Special Education. After this programme he/she, if a graduate, can join the **B.Ed. Special Education Programme** being offered jointly by IGNOU and RCI at the national level.

4.1 Background of Education of Children with Disabilities

- The 86th Constitutional Amendment of India provides free and compulsory education for children until they complete the age of 14 years. It has also made "Education" as the fundamental right for children upto this age and this right has been further enhanced by four years for children with disabilities.
- The National Policy on Education, 1986 made provision for the mildly and moderately disabled children to be placed for education in common settings.
- Section 26 of The Persons with Disabilities (Equal Opportunities, Protection of Rights and Full Participation) Act, 1995, has made provisions for the appropriate governments and local authorities to ensure that every child with a disability has access to free education in an appropriate environment till he attains the age of eighteen years. Under Section 39 it also ensures that every school offers 3% seats to children with disability.
- In order to encourage inclusion of children with Disabilities, in the mainstream school systems, the Government of India introduced the scheme of Integrated Education for Disabled Children (IEDC) in 1974.
- To give further impetuous to this approach, the Ministry of Human Resources and Development, Government of India, launched the Sarva Shikshya Abhiyan (SSA 2010) or "Education for All" to ensure entry, retention and education of children between 6-14 years of age including children with disabilities by 2010. SSA will ensure that every child with special needs, irrespective of the kind, category and degree of disability is provided education in an appropriate environment. SSA adopts 'zero rejection' policy so that no child is left out of the education systems. This scheme offers education to all the children including children with disabilities, through normal schools at their doorsteps and provides statutory provision of admission to disabled children in normal school and it also stresses that no elementary school in the country can deny admission to

a child with any disability. Thus, it has become necessary that at least one teacher from every elementary school in the country gets trained under the Foundation Course.

• Now the world has reset the goal to attain **Education for All** and **Health for All** by 2015 through its programmes of **EFA 2015** and **HFA 2015**.

India aims to become a developed country by 2020. **Development in real sense means 'Human Development' because man is the initiator, means and end of development**. In this context "Universalisation of Elementary Education" (UEE) will lay the foundation of development in the country. In order to create appropriate learning and teaching environment for successful inclusion of children with disabilities, in the mainstream schools, proper orientation of teachers and co-curricular staff to the unique learning needs of children with disability is a must. The role of the teacher in an integrated/inclusive set up goes beyond the traditional role, as s/he has to facilitate proper coordination and management of related services and support systems required by the disabled children. The teacher has to identify their educational needs and plan appropriate programmes for their effective participation in the curriculum and design appropriate methodologies. It has, therefore, become essential to sensitize the regular classroom teachers of the elementary schools in the country, at least one from each school so that they can meet the specific educational needs of the children with disabilities.

4.2 Aims and Objectives of the Foundation Course

The principal objective of the programme is to develop required competencies of in-service teachers and enable them to:

- deal effectively with the various educational needs of children with disabilities;
- impart education effectively to students with various disabilities in the classroom;
- to undertake appropriate classroom management for children with disabilities;
- to undertake remedial or dual teaching for children with mental retardation and learning disabilities.

4.3 Programme Content and Structure

The Programme of the Foundation Course on Education of Children with Disabilities in Distance Mode will consist of 5 Blocks with 4 Blocks of Theory and 1 Block of Practical component as detailed below.

4.4 Duration

The programme will be of 3 months (90 days) duration including 3 weeks of Face-to-Face Contact Programme in two phases. There will be a Term End Examination after second contact programme. Each enrolled candidate will get a maximum of three chances to clear the examination after which he/she will be eligible to get the Certificate. In case the candidate can not clear the programme in three chances then he/she will have to enroll afresh.

4.5 Time Schedule of the Programme

4.6 Process of Admission

The application forms for the admission in Foundation Course would be available round the year at the Study Centres/Regional Centre/IGNOU main office at Maidan Garhi. The interested learners can apply in the prescribed form and submit the application form to the Study Centre/Regional Centre. The Study Centres will collect the forms and submit to the Regional Centre. The process of finalisation of admissions takes 15 days time.

The Regional Centre will process the form and give admission to the interested learners. The list of selected learners would be sent to the respective study centres and SRD for necessary action. The programme would start in the prescribed month. In case more than 40 learners are enrolled at one centre. The rest would be either shifted to nearby centre or they would be given a chance in the next batch.

4.7 Implementation

The Programme will be implemented through Programme Study Centres that are RCI recognized institutions working in the area of disability. Each Programme Study Centre is governed and supported by the respective Regional Centre of IGNOU located at the state level. The list of the Programme Study Centres is at Annexure – I.

Each Study Centre can enroll a maximum of 40 Learners, for each of the February, June and October Sessions

4.8 Medium of Instruction

4.9 Eligibility

Any In-service teacher at any level.

4.10 Programme Fee

Programme Fee of Rs. 1500/- payble at the time of submission of application for admission. The Student Handbook & Prospectus with application form will be available at the Study Centre/IGNOU Regional Centres/University Headquarters, Delhi for Rs. 100/-. It can also be downloaded from IGNOU website.

Note: The Programme Fee should be paid only in the form of Demand Draft in favour of the "IGNOU, payable at the place of Concerned Regional Centre, New Delhi.

4.11 Despatch of Printed Study Material

The full set of study material for each student enrolled with a particular Programme Study Centre will be despatched in one lot to the Study Centre/Regional Centre. Students are required to collect the study material from the Study Centre/Regional Centre. In case of non-receipt of study materials, the Study Centre/Regional Centre may be contacted.

4.12 Practical Work

As a part of the Practical Papers Specific Block-wise assignments and Project Work have been assigned. These are to be submitted at the Study Centre as per the instructions of the study centre coodinator.

5. INSTRUCTION SYSTEM

The methodology of instruction at IGNOU is different from that in the conventional universities.

The Open University System is more learner-oriented, and the student is an active participant in the teaching-learning process. Most of the instruction is imparted through distance rather than face-to-face communication. The University follows a multi-media approach for instruction. It comprises:

- Self-instructional print material
- Face-to-face counseling at Programme Study Centres by academic counselors
- Assignments
- Practical Work

5.1 Print Material

Print material is the primary form of instructional material, although there will be a few audio-video programmes and counseling sessions. Therefore, you have to concentrate mainly on the printed materials that we sent you periodically. The printed material would be sufficient to write assignment responses and prepare for the term-end examinations.

5.2 Counseling

In distance education, face-to-face contact between the learners and their tutors/counselors is an important activity. The purpose of such a contact is to answer some of your questions and clarify your doubts which may not be possible through any other means of communication. It is also intended to provide you an opportunity to meet fellow students. There are experienced academic counselors at the Programme Study Centres to provide counseling and guidance to you in the courses that you have chosen for study. **Note:** An attendance of 75 per cent is compulsory for the contact classes.

Counselling sessions will be organized at the Programme Study Centre. In all there will be two Counselling sessions during the Programme,

- First Counselling session of 2 weeks (80 hours) just after registration for admission
- **Second Counselling session** of 1 week (40 hours) at the end of the programme, i.e., during the end of 90 days of the programme.

6. SCHEME OF EVALUATION

The **Scheme of Evaluation** will consist of two main components:

- Internal Assessment
- External Examination.

6.1 Block-wise Distribution of Marks

- For the Theory components of Blocks 1, 2, 3 & 4 the ratio of marks between Internal Assessment and External Examination.will be 20:80
- For Practical Components of Blocks 5 the ratio of marks between Internal Assessment and External Examination.will be 60:40

6.2 Methodology of Internal Assessment

- The internal assessment of the theory components of the course given in Blocks 1, 2, 3 & 4 will be based on 4 *Assignments, one for each Block of 5 marks each*.
- The internal assessment of the Practical components of the course given in Blocks 5 will be based on practical records and viva voce as given in Table below:

6.3 Instructional Hours and Allocation of Marks

The total instructional hours for the Foundation Course will be 240 hours including face-to-face instruction of 120 hours. The Programme has been assigned a total of 200 marks, which includes 100 marks for Theory and 100 marks for the Practical Components. *In the programme, emphasis is given to the development of practical skills for dealing with children with disabilities.*

In order to be successful in the Programme the candidate has to fulfill the following conditions: the candidate has to secure

- 1) a minimum of 40% marks in each of the two components, i.e., (1) *Internal Assessment*, and, (2) External *Examinations*, separately; in Theory Components
- 2) in any Practical Components a minimum of overall 50% marks in both(1) *Internal Assessment*, and, (2) *External Examinations*; and,
- 3) an overall 50% of marks in total aggregate.

7. TERM-END EXAMINATION

The Term End Examination (TEE) in Theory will be held at the last day of the Second Contact Programme. The duration of the examination will be two hours. The date of theory examination will be same throughout the country. Normally the Term End Eexamination (TEE) in Theory will be held on the Last Sunday of April, August and December.

The Term End Examination in Practical will also be conducted during the Second Contact Programme according to the suitability of the study centre. The date of practical examination may vary from centre to centre

7.1 Eligibility for Examination

The eligibility to appear in the examination is subject to the fulfilment of the following conditions.

- i) Filled in examination form along with exam fee of Rs. 50/-
- ii) Payment of all dues including the prescribed fees.
- iii) The student has at least attended 75 per cent of the prescribed contact clasees organised at the Study
- iv) Carried all the requirements for the Programme:
 - undergone practical training conducted during Contact Sessions.
 - completed and submitted prescribed number of assignments,
 - appeared in Theory and Practical Tests conducted during Contact Sessions,
 - completed Project Work and submitted the Report,
 - completed prescribed number of Teaching Practice Lessons.
- v) Student has not caused any act of indiscipline at the Study Centre
- vi) The University will be able to consider a student for granting permission to appear in the term-end examination, subject to the fulfillment of the above prescribed conditions.
- vii) Admit Cards will be issued by the University through the Coordinator of the concerned Study Centre. And it will be the responsibility of the students to collect them from there.

7.2 Examination Centre

Normally the study centre is the examination centre. However, a student is required to fill the examination centre code in the examination form. You are advised to go through the list of study centers available in the Student Handbook and Prospectus/ Programme Guide.

7.3 Award of Certificate to Successful Candidates

A successful candidate of the Programme will be issued a Marksheet & Completion Certificate by IGNOU.

7.4 Provision for Unsuccessfull Candidates

Unsuccessful candidates shall be permitted to appear at 2 subsequent examinations. After the expiry of this provision the candidates will have to seek fresh admission and no credit will be carried over.

Candidates eligible under the above provision and willing to appear in the subsequent examination(s) in any theory/practical component or both shall have to submit application on prescribed form together

with a copy of statement of marks obtained at the preceding examination through the Coordinator of the Study Centre so as to reach the Registrar by the date notified by him for subsequent examination(s).

A candidate will have to clear both theory and practical components in a maximum period of 12 *months after admission*.

7.5 RCI Certification

The successful candidates of this Foundation Course which has been jointly formulated by IGNOU and RCI will be eligible to get "*Provisional Registration*" *from the Rehabilitation Council of India* to impart education to the children with disability in Integrated/inclusive/general school.

- Declaration form signed by you.
- Demand Draft of Rs 1,500/- in favour of the **IGNOU** payable at the place of concerned regional centre and you have written on the back of the Demand Draft in capital letters: (a) Foundation Course (b) Application No.(mentioned on the Application Form), (c) Code Number and Name of the Study Centre, (d) Your Name and Address.

9.2 Address for Correspondence

Your address must be complete in all respects. The University will correspond with you at this address. If you change your address, you should inform the Programme Study Centre about your new contact address at once.

10. OTHER USEFUL INFORMATION

10.1 Reservation of Seats

The University provides reservation of seats for scheduled castes, scheduled tribes, non-creamy layer of other backward classes, war widows, Kashmiri migrants and students with disabilities as per the Government of India rules.

10.2 Scholarships and Reimbursement of Fees

Reserve categories viz., scheduled caste/scheduled tribe, other backward classes and students with disabilities, have to pay the fees at the time of admission to the University along with other students. Students with disabilities admitted to IGNOU are eligible for Government of India scholarships. They are advised to collect the scholarship forms from the Directorate of Social Welfare or Office of the Social Welfare Officer of the concerned State Government and submit the filled-in forms to them through the concerned Regional Director of IGNOU.

10.3 Issue of Duplicate Grade Card/Mark Sheet

A duplicate Grade Card is issued after a request is made on the prescribed form along with a draft of Rs.100/- to be paid in favour of IGNOU, New Delhi.

10.4 Simultaneous Registration

A student is permitted to register only for one programme in the given academic session. Students are, therefore, advised to seek admission to only one programme in the given academic session. Violation of this rule attracts cancellation of admission to all the programmes and forfeiture of the programme fees.
