Structure of the Course: The course consists of papers combining law and forensic science. The course will comprise of six papers and will focus on wide areas like IPC, CrPC, Evidence Act, Special Enactments, Jurisprudence, Medical Jurisprudence, Criminology, Penology, various psychological tests, applications of Ballistics, DNA fingerprinting, Toxicology, Narcotics, Explosives, Cyber crime, Fingerprints, Document Examination and other allied areas. Practical exposure and application of the forensic sciences will also be provided at the laboratory of GFSU which is well equipped with the latest and most advanced equipments and technologies for detecting the crimes. Classes will be held at GNLU/GFSU premises. The lectures will be conducted by the in – house as well as internationally acclaimed experts from India and abroad.



Selection Process: Through Entrance test.

Eligibility: A candidate should have passed any regular Degree or an equivalent degree from a recognized University of India or abroad.

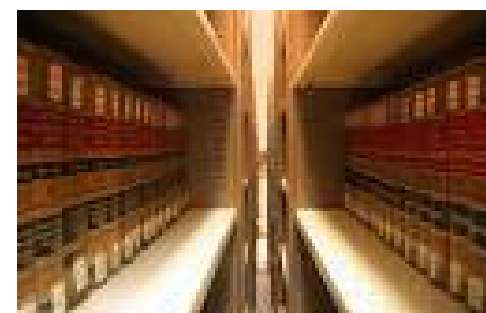
Age Limit: No Upper Limit
