#### **NOTIFICATION**

Applications for admission to the degree of Doctor of Philosophy (Ph.D.) in the prescribed form, are invited from the eligible candidates who are <u>exempted from taking entrance test</u> (candidates who have passed the UGC JRF/ CSIR JRF/ NET for Lecturership/ accredited SLET / GATE / M.Phil [admitted through an Entrance Test and with course work] and Government sponsored Foreign Students) for the year **2010-11**.

A candidate shall submit duly filled-in application form along with necessary documents to the Chairperson of the concerned Department on or before 19-01-2011.

#### MODES OF THE Ph.D. PROGRAMME:

- **a)** Full-time Ph.D. programme shall be undertaken by the eligible candidates who will work on regular basis in the department till the submission of the thesis.
- **b)** Part time Ph.D. programme shall be undertaken by the eligible candidates who do not prefer to pursue research on regular basis in the department till the submission of the thesis.

#### REQUIREMENTS FOR ADMISSION TO Ph.D. COURSE

- 1.1.1 A candidate, who has obtained a Master's Degree from this or any other University recognized as equivalent thereto securing not less than 55% marks or equivalent grade in the aggregate at the Master's Degree Course shall be eligible to apply for the Ph.D. Degree Programme in the concerned/cognate subject. However, in the case of SC/ST and the Category-I candidates the Minimum marks required shall be 50% or equivalent. Marks rounded off to make the percentage to 55 or 50 as the case may be through grace marks is not permissible for claiming Ph.D. registration.
- 1.1.2 Such of the teachers employed on Full-time basis before 31.03.1992 and who are continuing in service in any of the affiliated colleges, constituent colleges and PG Departments of any recognized University shall be eligible to apply for Ph.D. programme, subject to a minimum aggregate score of 50% (45% in case of SC/ST Cat-I candidates) at the concerned Master's Degree.
- 1.2.3 Exemption from Entrance Test
  - Candidates who have passed the UGC JRF/ CSIR JRF/ NET for Lecturership/ accredited SLET / GATE / M.Phil (admitted through an Entrance Test and with course work) and Government sponsored Foreign Students are exempted from the Entrance Test.
- 1.3.3 The Subject of research shall be the one in which the Candidate holds Master's Degree. However, candidates are also eligible to pursue the Ph.D. Programme in any other cognate subject, provided such subject is approved as cognate by the respective BOS (PG). Provision for research in cognate subject is only for academic purpose not for appointment.
- 3.1.3 The eligible candidates exempted from taking the Entrance Test shall submit duly completed application forms along with Bank Challan or Demand Draft towards payment of prescribed fees to the respective Chairpersons of the P.G. Departments on the main campus/P.G. Centres on or before the date stipulated.

### 4.0 Ph.D. Course Work

4.1 Registered Full-time and Part-time Ph.D. candidates (except the M. Phil candidates who have completed the degree as per UGC regulations 2009) shall undertake course work of one semester (16 weeks), normally in the Parent Department. However, if it is found necessary, course work may be carried out by doctoral candidates sister Departments/Institutes/Research Centers either within or outside the University for which due credit will be given to such candidates.

Part-time Ph.D. candidates, who are employed on regular basis, shall complete the course work on deputation for a period of 16 weeks. The course work shall be completed by every candidate on regular basis.
