## 1. Why CATE?

The Combined Aptitude Test for English (CATE), introduced by the Department of English, University of Delhi in 2009, is a centralised test meant to evaluate a student's aptitude for the study of BA (Hons) English offered by the University. From their experience, most teachers of English in the colleges of the University of Delhi have realised that a candidate's performance in the Class XII Examinations is not a good indicator of her/his aptitude for studying literatures in English.

Until a few years back, a number of colleges offering BA (Hons) English used to admit students through entrance tests in their respective colleges. However, the University administration felt that too many individual college tests put undue pressure on candidates, who had to run around from college to college attempting these tests.

After the individual tests were scrapped, some colleges got together at the initiative of the Department of English, University of Delhi, and following long deliberations among teachers from the colleges, the University Department and officials of the University, the Combined Aptitude Test for English (CATE) was developed.

The inaugural CATE was held in 2009, with twelve colleges participating in the process. A CATE committee was duly constituted comprising members of the University Department and teachers from colleges. Once the process began, the Committee was overwhelmed by the response. More than 6000 candidates appeared for the test in 2009 and in 2011 the number had increased to nearly 10000. The number of participating colleges has also gone up to 21 (See page 10 for the list of colleges participating in CATE in 2012).

## 2. Eligibility

Eligibility for CATE is as per the University rules of eligibility for admission to any BA (Hons) course. For calculating their aggregate marks candidates may use any one of the following subject combinations:

- i) English PLUS any 3 academic subjects (including languages)
- OR**
- ii) English PLUS 2 academic subjects (including languages) PLUS one vocational subject

**General category candidates** should have a minimum of 45% marks in the Class XII Board Examinations.

**OBC candidates (non-creamy layer)** will be given a relaxation of 10% of the minimum eligibility marks prescribed for the General category candidates. The eligibility therefore would be 40.5% (10% of 45 subtracted from 45%).

**Children/Widows of eligible Armed Forces personnel (CW)** will be given a concession of 5% marks in the minimum eligibility requirements, i.e. these candidates should have scored 40% marks in their Class XII Board Examinations to be eligible for appearing in CATE.

**SC/ST candidates and Persons with Disabilities (PWD)** are exempted from CATE. Their admission will be as per the rules of the University.

No rounding off is allowed in the aggregate marks. For example, 44.9% aggregate can not be rounded off to 45%.

**Please see the DU information bulletin for further details of eligibility and admissions.**

**Note: All candidates may need to submit other forms as required by the University of Delhi for admission to non-CATE colleges offering BA (Hons) English as well as for any other course. The CATE form is valid only for admission to BA (Hons) English in colleges participating in CATE.**

### 3. CATE 2012

CATE 2012 will be held on Saturday, 9 June 2012 from 11 am to 1 pm. The duration of the test will be 2 hours.

CATE is designed to test a candidate's aptitude for BA (Hons) English as a course of study, and to that end, it aims at evaluating language, grammar, and writing skills as well as general literary awareness.

The question paper will consist of two parts. Part A will comprise multiple choice questions (MCQs) and Part B descriptive-answer type questions (comprehension and essay/creative piece). Students will attempt both parts in the same sitting. However, only the scripts of those students who qualify in Part A will have their Part B scripts evaluated.

The final aptitude quotient, known as the CATE score, will be determined by collating the Class XII Examination marks (Best 4) and the CATE marks on a ratio of 30:70. A merit list of candidates will be made on the basis of such a collation. Separate merit lists will be prepared by the Department of English, University of Delhi for different categories (General and OBC) along with one consolidated merit list. The participating colleges will admit candidates to the course on the basis of cut-off points declared by them after the CATE scores are announced.

The University administration has made it clear that colleges not participating in CATE.

- a. MAY NOT conduct a separate test of whatever description to admit students, and have to go strictly by the Class XII marks;  
AND
- b. MAY NOT use the CATE score as a criterion for allowing/denying admission to any candidate.

### 4. Sale and Receipt of Application Forms

The OMR Application Form can be purchased at any of the centres designated for the sale and receipt of forms from Friday, 25 May to Monday, 4 June 2012, by submitting a bank draft of Rs.350 in favour of **The Registrar, University of Delhi**, drawn on any branch of the following banks:

Please note that drafts from any of the subsidiary State Banks (for example, State Bank of Patiala, State Bank of Mysore, State Bank of Travancore etc.) will NOT be accepted. The drafts should be payable at Delhi.

The Form has to be purchased/submitted in person only. NO Application Forms will be accepted by post/courier.

## 5. Instructions for Filling out the Optical Mark Reader (OMR) Form

- The OMR Application Form will be supplied in an envelope along with the Information Bulletin on payment of the requisite amount through Demand Draft. The amount charged for the Information Bulletin and the Application Form will cover the Test fee as well. No further payment is to be made at the time of submitting the form. Candidates are required to fill out the Application Form as per instructions, put it in the same envelope, and submit it in person at any of the designated centres.
- The completed OMR Application Form is to be submitted with the original folds. No new folds should be made.
- Circles in the OMR Application Form can be filled either with an **HB pencil** or with a **black ball point pen only**. Candidates should fill in the appropriate circles with due care, especially if pens are used. In case the Application Form is filled in with a pencil, they may change the entries by completely erasing wrongly filled circles. The erasing must be complete, without any smudges, as partially erased marks may lead to wrong reading by the OMR. Therefore, particular attention should be paid while filling in data in the Application Form.
- Candidates should use only a black ball point pen for writing their address and signing the form.  
**Do NOT use a pencil for writing the address or for your signature.**
- Candidates are advised to first fill in the boxes in the form and then proceed to darken the relevant circles.
- All circles must be completely darkened. The letter/number in the circle should not be visible after the circle has been darkened.
- The responses should be marked only in the space provided for the purpose. Responses marked elsewhere will not be considered.
- Only one letter/digit should be entered in each box. In case of a gap between words, the relevant box and the circle under it may be left blank.
- For Columns No 2, 3, 4, 5 and 8, candidates should only write the numerals provided in the respective boxes.
- The OMR Application Form has three parts separated from each other by perforations. Part 2 is the Admit Card and Part 3 the Acknowledgement Slip. These three parts should not be separated from each other. In case these get separated, all three parts should be kept in the same envelope while submitting the form.
- The OMR Application Form is not to be tampered with in any way. Candidates should NOT make any stray/random marks on the form and should take care NOT to staple, pin up, wrinkle, scribble on or wet it. The barcode on the form should not be tampered with. Any form found tampered with in any manner is liable to be rejected.
- Any error in filling up the OMR Application Form may result in rejection. An Application Form without photograph and/or signature shall be rejected.
- Candidates are advised to keep a photocopy of the OMR Application Form and the receipt issued. However, such a photocopy will not automatically entitle the candidate to get a duplicate Admit Card.
- Registration of the candidates shall be based on the data given in the OMR Application Form. The candidate shall be responsible for the authenticity of the data.
- On the day of the test, candidates are advised to report at least 30 minutes prior to its commencement to their designated test centres.



## 6. Frequently Asked Questions (FAQs)

### 1.1. ABOUT THE FORM

- **When will the CATE forms be available?**

The CATE forms will be available from Friday, 25 May 2012 to Monday, 4 June 2012 at the centres designated for sale and receipt of forms. Forms will not be sold on Saturdays and Sundays.

- **Where and how can I buy the form? What is the cost?**

You can buy the forms at the centres designated for sale and receipt of Application Forms from Monday to Friday, 10 am to 1 pm and from 2 pm to 4 pm for the Day Colleges and 4 pm to 7 pm for the Evening Colleges. The list of centres is given on page 11. The Application Form can be purchased by submitting a bank draft of Rs.350 in favour of **The Registrar, University of Delhi**, drawn on any branch of the following banks: State Bank of India, Punjab National Bank, ICICI Bank and HDFC Bank. Please note that drafts from any of the subsidiary State Banks (for example, State Bank of Patiala, State Bank of Mysore, State Bank of Travancore etc.) will **NOT** be accepted. The drafts should be payable at Delhi only.

**Please write your name, address and contact number behind the demand draft, before submitting the same.**

- **Can I apply online for CATE?**

No. There is no online application process for CATE.

- **Can I purchase/ submit the Application Form by post?**

No. The forms have to be purchased and submitted in person. No Application Form will be sent or received by post.

- **Do I have to submit the completed Application Form at the same centre where I purchased it?**

No. You can submit the form at a centre different from the one where you purchased it.

- **I am an outstation candidate. Can I send someone else to fill out the form for me?**

You will need to fill out and sign the form yourself. However, someone else may purchase and deposit the form on your behalf.

- **How should I fill up the Application Form?**

Before you start filling up the Application Form, please read the instructions given on page 4 very carefully. Please remember that the form should be filled in with a **black** ball point pen or pencil only. The signature and the address of the candidate should be filled in with a **black ball** point pen **ONLY**.

- **Do I need to fill out any other form for admission to BA (Hons) English in a CATE college?**

No. You need to submit only one OMR Application Form to apply for admission to BA (Hons) English in all the colleges participating in CATE.

- **Do I need to fill out any other form for admission to BA (Hons) English in non-CATE colleges?**

Please refer to the University of Delhi Information Bulletin or the University website [www.du.ac.in](http://www.du.ac.in) for details on the admission process for BA (Hons) English in non CATE colleges..

- **Do I need to fill out any other form for admission to any other course apart from BA (Hons) English?**

Please refer to the University of Delhi Information Bulletin or the University website [www.du.ac.in](http://www.du.ac.in) for details on the admission process for all undergraduate courses.

- What are the minimum eligibility criteria for appearing for CATE?**  
 The minimum eligibility criteria are as follows:  
 General category candidates: 45% marks in the Class XII Board Examinations  
 OBC (non-creamy layer) candidates: 40.5% marks in the Class XII Board Examinations  
 Children/Widows of Armed Forces personnel: 40% in the Class XII Board Examinations
- Which subjects can I include in my Best 4?**  
 You can use any of the combinations listed below:  
 i) English PLUS any 3 academic subjects (including languages)  
**OR**  
 ii) English PLUS 2 academic subjects (including languages) PLUS one vocational subject
- How will I know which of my subjects are academic and which vocational?**  
 Please refer to page 11 for a detailed list of academic and vocational subjects as approved by the University of Delhi.
- I have only two academic subjects. Am I eligible to apply for CATE?**  
 No. You should have at least three academic subjects in order to apply for CATE.
- Can I include Physical Education, Painting, Informatics Practices, Home Science etc. in my Best 4?**  
 Please see the list of academic and vocational subjects on page 11.
- I have a compartment in one subject. Am I eligible to apply for CATE?**  
 As per prevailing rules of the University of Delhi provisional admission may be given to candidates with compartment in one subject on the following condition:  
  
 They should have the required minimum percentage of marks in the aggregate by adding the minimum pass marks of the subject in which they have been placed under compartment to the marks obtained in the other three subjects. Therefore, if you have a compartment in one subject and wish to appear for CATE, the marks in your compartment subject must be included in the best 4. (Marks in Subject 1+ Marks in Subject 2+ Marks in Subject 3+ minimum pass marks in the subject in which you have been placed under compartment).

**Candidates who fail to appear for or pass the Compartmental Examination in the year of admission shall not be entitled to continue on rolls and their provisional admission will be cancelled.**
- What do I need to submit along with the Application Form?**  
 You do not need to submit any document with the Application Form. ALL documents will be verified at the time of college admission.
- My Class XII result has not been declared yet. Can I apply for CATE?**  
 You can apply for CATE in the Result-awaited category only if your Class XII result is not declared by the last date of submission of CATE forms.
- I applied for CATE in the Result-awaited category. How will I know my CATE score?**  
 If your results are delayed then you can apply by filling in the Result-awaited column. Once the result is declared you will have to meet us at the Department of English, Faculty of Arts, North Campus, University of Delhi, with a hard copy of your result (it can also be a printout from the internet). We will then validate the result and give you the CATE score.  
 However, if your result is expected to be declared before the last date of submission of CATE forms then we advise that you apply only after it has been declared. This will save you the trouble of having to inform us later by physically meeting us at the Department of English at The University of Delhi.

- **I had applied in the Result-awaited category. But now my result has been declared and I am not eligible for the Test. Can I get a refund of the Test fee?**  
The Test fee will not be refunded under any circumstances.
- **The subject codes given in this Information Bulletin are different from the codes my subjects had in my Board Examinations. Which codes should I use?**  
You have to use the codes given by us in the Application Form.
- **I made a mistake in filling in my Application form. What should I do?**  
Incomplete or incorrectly filled forms will be rejected. Overwriting or using eraser/correction fluid is not allowed.
- **I filled the form in blue ink instead of black as specified. Will my form get rejected?**  
Any form not filled as per specifications is liable to get rejected.
- **I have a gap of some years after my Class XII Examinations. Am I eligible to appear for CATE?**  
As per the rules of the University of Delhi, "gap year/years would be no bar for purposes of admission to the undergraduate courses." Therefore, provided you fulfill the minimum eligibility criteria for appearing for CATE, you are eligible to appear for the test.

### 1.1. ABOUT THE TEST

- **When and where will the Test be held? What are its timings?**  
The Test will be held on Saturday, 9 June 2012 from 11am to 1 pm at the Test centre allotted to you.
- **When and where will the results be declared?**  
The results will be published latest by 25 May 2012 on the website of the University of Delhi ([www.du.ac.in](http://www.du.ac.in)).
- **How will I get my Admit Card?**  
Your Admit Card can be downloaded after a period of 3 days from the date when you submitted the Application Form. In any case, all Admit cards will be generated latest by 6 June 2012.
- **What if my Admit Card is not available on the website?**  
If your Admit Card is not available then your form may have been rejected. The list of the rejected applicants will be made available on the website.
- **My Admit Card has not been generated, nor is my name on the rejected list. What should I do?**  
Please contact the Department of English, Arts Faculty, North Campus, University of Delhi with a copy of the duly signed and stamped Acknowledgement Slip issued to you while submitting the form and a copy of your Class XII marksheet. We will look into the matter.
- **What if I lose my Admit Card?**  
You can download the Admit Card again from our website and take a printout.
- **At what time do I need to report for the Test?**  
You are required to report to your Test centre, as given on your Admit Card, **at least 30 minutes** prior to the commencement of the Test.
- **What do I need to carry to the Test centre?**  
You will need to carry the following to the Test centre:
  - i) Your Admit Card.
  - ii) HB pencil
  - iii) Black-ink ball pen



- **What will be the pattern of the test?**  
The question paper will consist of two parts. Part A will comprise multiple choice questions (MCQs) and Part B descriptive-answer type questions (comprehension and essay/creative piece). You will attempt both parts in the same sitting.
- **Is there any sample paper made available by the University?**  
No, there is no sample paper.
- **Is there any study material prescribed by the university for CATE?**  
No. There is no study material prescribed/sold by the university for CATE.
- **Will there be any negative marking?**  
No. There will be no negative marking.
- **Will there be an elimination round?**  
Yes. While all students will attempt both parts of the paper, only the scripts of those students who qualify in Part A, as per standards laid down by the university, will have their scripts for Part B evaluated.
- **How will the CATE score be calculated?**  
The final aptitude quotient, known as the CATE score, will be determined by collating the Class XII examination marks (Best 4) and the CATE marks on a ratio of 30: 70. A merit list of candidates will be made on the basis of such a collation. Separate merit lists will be prepared for both the categories (General and OBC) along with a consolidated merit list.  
  
Therefore, if you have scored 60% in the aggregate of your Best 4, and 80 in CATE, your final CATE score would be 30% of 60=18 + 70% of 80 =56, i.e. 18+56 = 74
- **I am a blind candidate. Will you be providing me with a scribe?**  
No. You will bring your own scribe to write for you in the test. Please keep in mind however that as per rules, the qualifications of the scribe should not be HIGHER than that of the candidate (i.e. the scribe must be in Class XII or less). You will both need to sign an undertaking to this effect before the commencement of the test.  
Extra time will be given as per the rules of the University.

### 1.1. ABOUT ADMISSION

- **How do I secure admission to a college on the basis of my CATE score?**  
Once the results of CATE have been declared, the participating colleges will decide their respective cut-off points for admission based on the CATE score. Students who are eligible for admission on the basis of these cut-off points may present themselves to any of the colleges participating in CATE within whose cut-off points they qualify. The college will reserve the right to verify the authenticity of the candidates' qualifying documents. A student will be denied admission if any information supplied is found to be false.
- **Does qualifying in the aptitude test automatically entitle me to admission in any CATE college?**  
No. Just qualifying the aptitude test does not entitle you to admission. You will need to qualify on the basis of cut-off points announced by the respective colleges.
- **I qualified CATE last year but did not take admission. Can I take admission this year on the basis of last year's CATE score?**  
No, the CATE score is valid only for the year of taking the test.
- **Can a participating college use any other parameters of examination, such as Interview or Group Discussion, apart from the CATE score?**  
No, a participating college cannot examine students on any other parameter apart from their CATE score.
- **If my results are not declared by the time the CATE scores are published, what should I do?**  
Please contact the Department of English, Arts Faculty, North Campus, University of Delhi in Person.

- **I submitted the form in the Results-awaited category. My results have been declared now and the CATE results have not yet been published. What should I do?**  
Please contact the Department of English, Arts Faculty, North Campus, University of Delhi, in person with a copy of your Class XII marksheet.
- **The CATE results have been declared. I included the wrong subjects in my Best 4. What should I do?**  
Please contact the Department of English, Arts Faculty, North Campus, University of Delhi, in person with your Class XII marksheet.
- **Can a college recalculate my CATE score?**  
No. The CATE score published by the Department of English is final and binding on colleges.
- **Can a college offer any other kind of relaxation (For example, for girl students, for students having studied a particular language such as Urdu or Arabic in Class XII etc.) on the CATE score?**  
No. The CATE score is final and binding for each category (General, OBC and CW) and colleges may not offer **any additional relaxation** to students **applying for admission to BA (Hons) English in the college.**
- **I am an OBC category candidate. However as per my CATE score, I qualify the cut off for General category candidates in the college of my choice. Can I take admission in the General category?**  
If you qualify the cut off announced by a college for General category candidates, you will be admitted as a General category student.
- **Will a second merit list for CATE be published?**  
No. Only one merit list will be published for each of the categories.
- **Will a second cut off list be brought out by colleges for CATE?**  
Colleges may bring out one or more than one cut off list for admission in the various categories depending upon the availability of seats.
- **My name does not appear in the CATE merit list? Why is it so?**  
If you appeared for the CATE and do not find your name on the merit list, it is because you have not qualified in the exam.
- **I am an SC/ST candidate. Do I need to take the test?**  
No, you are exempted from CATE. Your admission will be as per the rules of the University.
- **I am a PWD candidate. Do I need to take the test?**  
No, you are exempted from CATE. Your admission will be as per the rules of the University.
- **I am a CW candidate. How will I secure admission?**  
As per the rules, you will appear for CATE, but the admission procedure will be as per the rules and guidelines of the University.
- **What relaxation is available for OBC (non-creamy layer) students at the time of admission?**  
OBC candidates belonging to the non-creamy layer will be given a relaxation in the minimum eligibility to appear for CATE. A separate merit list will be prepared for them and colleges will announce separate cut offs for OBC candidates.

#### 1.1. OTHER INFORMATION

- **Are foreign candidates exempted from CATE?**  
Yes. These candidates will be admitted by the colleges as per the prevailing rules of the University of Delhi and should contact the Foreign Students Advisor (FSA).

- **Will candidates seeking admission through Sports/ECA (Extracurricular Activities) quota have to appear for CATE?**  
No. These students will be admitted by the different colleges as per the prevailing rules of the university.
- **I am an International Baccalaureate student. How will my CATE score be calculated?**  
Your CATE score will be calculated by using the formula for conversion from Grade to marks scheme as followed by the University of Delhi. Please note however, that we will **not** provide admission on the basis of your predictive scores.
- **Can I take the test again next year?**  
There is no restriction on the number of times you appear for CATE.
- **I do not fulfil the minimum eligibility criteria for CATE. I have applied for reevaluation of my Class XII papers. Can I still appear for the test?**  
No. You can appear for the test ONLY if you fulfil the minimum eligibility criteria at the time of applying.
