Applications are invited from dental graduates (BDS) for the Post Graduate (MDS) Competitive examination at **Manubhai Patel Dental College, Vadodara** for the following subjects -

- (2) Oral Pathology & Microbiology
- (3) Orthodontics & Dentofacial Orthopedics
- (4) Periodontology
- (5) Prosthodontics & Crown & Bridge.

(Reservation of Seats in SC/ST/SEBC as per Rules of Govt. of Gujarat)

Admission Notice- Self Financed Dental Colleges

Post Graduate Dental Courses (MDS), 2012

1. Applications in the prescribed form are invited for admission to the Post Graduate Dental Courses of colleges affiliated to Bhavnagar University. The fees structure of the 2012-2013 academic batch shall be **Rs.4,70,000/year** or as per Hon'ble RJ Shah Committee or as per the direction of Central Govt./State Govt./Competent Authority.
2. Total No. of Seats: 15 for the Academic year 2012-2013 (**15% NRI Quota and for the remaining seats 85% seats - 50% (42.5%) - University Quota & 50% (42.5%) Management Quota**) as per the direction of Hon'ble High Court of Gujarat. The above distribution of seats can be changed as per the directions of Dental Council of India/ Central Govt./ Hon'ble Supreme Court from time to time. (***Please note the seat distribution below for academic years 2012-2013 and 2013-2014**).

In case additional subjects of MDS are added in the following years, the changes of seat distribution for University Quota, Management Quota & **NRI quota** will be notified in the admission notice to be published each year.

3. The Application Form, before submission, should be completed in all respects in every detail. The application & examination fees of Rs. 10,000 (non refundable) must be submitted at the time submission. No alteration or addition will be permitted later on. Duly certified copies of required documents should be attached.
4. None of the accompaniments will be returned. All original certificates, the copies of which are attached to the Application Form must be brought at the time of interview for verification. Original mark sheets of the admitted candidates will be returned by the authority. Last date of acceptance of completely filled in Application Form with entrance examination fee receipt is provided in programme schedule section 12.
5. Every candidate will be issued a receipt with photograph when he/she submits his/her application form with application fees. This must be preserved for all future references and produce when asked for.
6. Only those applications along with Examination Fees and required documents received up to last date will be considered. Any application received later than the last date, application with insufficient details, or required documents or required fees shall be rejected without any explanation even if it is received within date and time.
7. If any of the statement made in the application form or any information/document supplied by the candidate in connection with the application for admission is found to be false or incorrect or misleading or if it is found that the candidate has concealed any information /fact in connection with his application, the application form shall be rejected/his admission shall be cancelled without any notice thereof, fees forfeited and he may be expelled and prosecuted.

8. ELIGIBILITY CRITERIA

- a. A candidate for admission to the MDS course (Master of Dental Surgery) must have completed his/her rotating Internship by the **31st of May** of the same year and have a degree of BDS (Bachelor of Dental Surgery) from a college and University recognized by Dental Council of India under section 10(2) of the Dentist Act, 1948 or an equivalent qualification recognized by DCI.
- b. Candidates should have permanent registration with a State Dental Council.
- c. Candidates not possessing a recognized Dental qualification for the above purpose must secure the prior approval of Dental Council of India before he/she can be admitted to the MDS Course.
- d. Candidates who possess PG Diploma recognized by the DCI with the duration of 2 years (proposed) in particular specialty is eligible for admission in MDS in the same specialty and the duration will be 2 years. The syllabus of the two years programme will be as per the concerned University guidelines and Dental Council of India.
- e. In the case of foreign nationals, the Dental Council of India may on payment of the prescribed fee for registration grant temporary registration for the duration of the postgraduate training restricted to the dental college/ institution to which he is admitted for the time being exclusively for postgraduate studies. Provided that further temporary registration to such foreign national shall be subject to the condition that such person is duly registered as dental practitioner in his own country from which he has obtained his basic dental qualification and that his degree is recognized by the corresponding dental council or concerned authority.
- f. A candidate who is currently engaged in Post Graduate Dental Studies in Bhavnagar University or any other University or equivalent body is not eligible. On completion of the course that is after passing the University Examination for that course, he/she becomes eligible for another Post Graduate Dental Course.

9. Selection of Postgraduate Students as per the Gazette of India: Self financed

colleges affiliated to Bhavnagar University, Gujarat, India

- a. The selection and admission of the candidates shall be in the hands of both, the management of the self financed institute and the University.
- b. The right to admission of **15% NRI quota and 50% (42.5%) of remaining seats** shall be reserved for **management** of self financed to be duly filled independently by the management of dental college on the basis of eligibility criteria.
- c. The other **remaining 50%(42.5%)** of the post graduate seats shall be reserved for **University (Govt.) Quota to be duly filled by University through competitive exam at Examination Centre, Bhavnagar and** on a preferential basis as indicated below:
 - i. 1st Preference: shall be given to eligible students graduated from Bhavnagar University passed on the basis of a Merit list formed by the University.
 - ii. 2nd Preference: shall be given to eligible students who have graduated any government university of the state of Gujarat.
 - iii. 3rd Preference: shall be given to eligible students who have graduated from any of the deemed Universities of the state of Gujarat.
 - iv. 4th Preference: shall be given to eligible candidates who have graduated from other recognized Universities of India.
 - v. 5th Preference: shall be given to International students of equivalent BDS degree as per norms of Dental Council of India.
- d. Separate merit lists for Unreserved, SC, ST and SEBC will be prepared as per the rules of Govt. of Gujarat from the result of the competitive test for University Quota. The Merit lists will be displayed on the notice board/Online within ten days of conduction of the test.
- e. **For allocation of University Quota (Govt.) seats (SC/ST/SEBC/OPEN) a 100 point roster register as per government of Gujarat's rules will be followed, record of which (roster register) will be maintained by the Respective**

College/Institutions. These Roster point list will be separate for affiliated institutions / Colleges.

- f. The committee comprising the Dean, Heads of the Department of concerned dental college, and Chairman/representative of the trust/faculty dean of dentistry will call candidates merit wise for counseling.
 - g. The candidates will be called according to Merit list and shall be given admission according to the choice of subjects (Prosthodontics, Periodontology, Orthodontics, Oral Pathology & Microbiology & Conservative Dentistry & Endodontics) **if vacant according to reservation criteria as rules of the Govt. of Gujarat.**
 - h. The candidates shall not be allowed to change the choices/preferences of the seat at the time of counseling.
 - i. In case a candidate does not join the day fixed by the Dean as incoming post graduate student, the vacant seat will be allotted to the next candidate in the merit list **before 31.05.2012.**
 - j. A candidate seeking admission to the MDS Course shall register under the recognized post graduate teacher in the University.
10. The selected and admitted candidates are required to pay the fees of concerned college / Institute as determined from time to time, failing which their admission will be cancelled without any notice and he/she will be debarred from applying in future. If a student leaves the course after admission confirmation/joining and payment of fees, no refund shall be given to them.
11. Original documents as required, of admitted candidate will be retained by authority.
12. **Programme (University Quota 50% (42.5%))**
- a. Application forms for the University Quota seats along with relevant rules shall be available from **1/5/2012 (Tuesday)**, from 11.00 am to 1.00 pm and 3:00 to 4.00

pm from the offices of relevant affiliated dental colleges having MDS courses.
The forms will also be made available online on the University Website www.bhavuni.edu

- b. Last date for acceptance of completed application form and fees along with entrance examination fee receipt is up to **10/5/2012(Thursday), 4:00 pm.**
- c. Entrance examination (3 hrs) based on the pattern of 200 MCQ's from undergraduate dental studies shall be held on the **20/5/2012(Sunday) at 11:00 am to 2:00 pm** at the affiliated dental colleges or as per notice of University.
- d. Results & Merit lists will be declared by **22/5/2012** on the website.
- e. Counseling will be held on **24/5/2012 at Bhavnagar University.**
- f. Academic year will start from the **1st of June 2012.**
