## CIRCULAR

Subject: Complaint Policy of the Corporation.

With reference to above, 'Complaint Policy' of the Corporation, duly approved by the Competent Authority, is as follows:-

- 1. The Corporation presently has a vigilance set-up headed by a Chief Vigilance Officer (on deputation) and assisted by a General Manager at Head Office of the Corporation and each Branch has a Vigilance Officer having a long experience in the field of cotton.
- 2. Complaint is generally one important source of information for identification of vigilance related issues in the Corporation. As per the arrangement, the details of officials with whom a complaint can be lodged are displayed at the main entrance of the Corporate Office as well as at the Branch Offices. Any person/public can lodge complaint in person or by addressing a letter directly to the Managing Director or to the Chief Vigilance Officer at Head Office and Branch Manager & Vigilance Officer at Branch Offices giving therein the facts of the matter relating to corruption, misconduct, malpractices, etc. (The identity of the complainant is kept confidential).
- Any complaint disclosing allegations of corruption is dealt with as per instructions of the Central Vigilance Commission/Redressal of grievances is not the focus; it's dealt separately by the Corporation.
- Anonymous/Pseudonymous complaints are not entertained.
- A complaint received from public, any administrative authorities, NGOs, etc. is recorded in a Register known as Complaint Register and each complaint is given specific number.
- Only those complaints, which are against an official of the Corporation and have allegations of corruption i.e. vigilance angle, are investigated by the Vigilance Officer. Complainant is always encouraged to share the information/details with regard to his complaint.
- 3. After completion of the investigation, the Vigilance Officer submits his report to the Branch Manager with copy to Vigilance Cell at Head Office. Action on such report is taken by the Disciplinary Authority concerned taking into consideration the facts and circumstances of the case.
- 4. The Corporation has no jurisdiction over private individuals and State Governments/Central Government. Therefore, complaints against officials of the Corporation only will be entertained.

- 5. Whenever the complainant for valid reasons requests that his identity be withheld while processing the complaint, this will be ensured by the Corporation.
- 6. Complaints must be brief and contain factual details, verifiable facts and related matters. They should not be vague or contain sweeping general allegations.
- 7. Complaint should be addressed directly to the Corporation. Complaints marked to a large number of functionaries are not normally pursued by the Corporation.
- 8. Corporation will acknowledge only those letters which are being got investigated by it. A complaint number will be provided to the Complainant.
- 9. Corporation will not entertain any further correspondence in the matter, but will ensure that the complaints are investigated and action taken to its logical conclusion.
- 10. If the investigation into a complaint leads into an area beyond the purview of enquiry by Vigilance Officer of the Corporation, then it may be referred to the Central Bureau of Investigation for further necessary action at their end.
