**4. Terms and Conditions:**

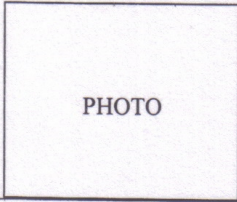
1. Appointment will be on Part-Time hourly remuneration basis for the post mentioned at Sl. No. 01 & 02 and on contract basis on consolidated pay initially for one year liable to be extended/ curtailed at the discretion of the Competent Authority for the post of Office Superintendent (Acad) at Sl. No. 03.
2. No other service benefit at par with the regular employees of the Institute will be admissible to the appointees.
3. The person selected will be required to work on holidays and on non-working days, if required.
4. The appointment will be on hourly basis for Sl. No. 01 & 02 and on contractual for Sl. No. 03 respectively.
5. A contract agreement will have to be signed with the Institute by the selected person on contractual engagement for post mentioned at Sl. No. 03. Signing of Contract agreement is not applicable for post mentioned at Sl. No. 01 & 02.

6. The contract of the person appointed against Sl. No. 03 may be terminated by either side with a prior written notice of one month. The institute will be at liberty to terminate the contract at any time with immediate effect by paying the contractual remuneration of one month in lieu of one month notice.
