Minimum Pre-qualification Criteria:

1. The Original Equipment Manufacturers (OEM's) of Air-Conditioning systems only eligible to apply for this work.
2. The OEM's shall have minimum 7 years presence in India.
3. The OEM's shall have proper office infrastructure at Ahmedabad/Baroda.
4. The average financial turnover during the last 3 years, ending 31st March 2012 shall be minimum Rs.200 Crore per year. The Balance sheet certified by CA to be produced.
5. The applicant OEM shall have the following minimum installations during last 7 years.
 - (a) At least 3 similar works (Air-cooled Screw Chillers) of minimum Rs.30 Lakh each out of which at least one should have been in Ahmedabad/Baroda.

Or

 - (b) At least 2 similar works (Air-cooled Screw Chillers) of minimum Rs.40 Lakh each out of which at least one should have been in Ahmedabad/Baroda.

Or

 - © At least one similar work (Air-cooled Screw Chillers) of minimum Rs. 70 Lakh. If this single work is carried out at place other than Ahmedabad/Baroda then at least one another work of value Rs.40 Lakh should have been in Ahmedabad/Baroda.
6. The applicant shall have experience of having executed similar works for Govt/PSU/Nationalized Banks and shall not have any discouraging/adverse report about the firm.
7. Required information should be submitted in the format given below.
8. The firm shall enclose documentary evidence such as PO copy, completion certificate etc. in support of the work details furnished by them stating the value of work and other salient features of work.
9. The firm / company should have registration with service tax, VAT, PF, ESIC and Prof.Tax.

General terms & Conditions.

1. The preference will be given to the vendors who have office at Ahmedabad/Baroda for prompt service.
2. The application shall be submitted in accordance with the Annexure-I&II duly filled in. The list of similar jobs carried out by the vendor in the past and the copies of the work orders, completion certificates, references and contact numbers of the clients shall also be submitted.
