APPOINTMENT OF PART-TIME MEDICAL CONSULTANT ON CONTRACT BASIS.

The present Model Scheme for Appointment of Part-time Medical Consultants on contract basis is as under:-

1	Basic Qualification	M. D. in general Medicine (P.G. qualification recognized by Medical Council of India) with atleast -3- years experience after passing M.D.
		In case Doctors with M.D. qualification is not available, Doctor with basic Qualification of M.B.B.S. and having atleast -5- years of experience after passing M.B.B.S.
2	Age	Should not be more than -50- years of age as on 01.12.2012 and shall not be allowed to continue beyond -60- years of age.
3	Period of Contract	Initially, the appointment shall be for a period of one year and on satisfactory completion of the same, the contract shall be for -3- years including the initial period of one year. (i.e. for next 2 years).
4	Consolidated Fees.	The consolidated fees of M.D. Doctor at Gandhinagar will be Rs.18,000/- (Inclusive of Petrol/ conveyance expenses). The consolidated fees of M.B.B.S. Doctor at Gandhinagar will be Rs.12,500/- (Inclusive of Petrol/conveyance expenses).
5	Compounder Fees	The charges payable to the Part-time Medical Consultant for the services of a compounder shall be as under: At Gandhinagar: Rs.1,100/- per month.
6	Working Hours	The Minimum working hours shall not be less than 15 yours per week (Monday to Saturday).
7	Termination of Contract	The contract can be terminated by one month's notice on either side at any time during the subsistence of the period of contract.
8	Other Conditions	Part Time Medical Consultants shall not be eligible for any benefits as available to Part-time/Full-Time employees of the Bank i.e. they will not be eligible for any Leave, Leave Fare Concession, Provident Fund, Gratuity or any other terminal benefits, Bonus, Reimbursement of Medical Expenses, Brief Case, News papers etc. Except the services of the Compounder, no other person will be allowed to be engaged by the Medical Consultants.
