#### **Professor S.N. Singh** Dean and Head

The best Law Faculty, established in 1924, is at the threshold of great expansion and innovation. The hallmark of this expansion and innovation is the decision of the University to integrate all the three Law Centres into one single unit. To be located in an area of nearly 13 acres at Dhaka, the existing faculty of 75 will add 212 new members. From the academic



year 2010-11, the Faculty would increase admission intake by 54% as decided by the University to give full effect to 27% reservation in admissions in LL.B. and LL.M. courses for the socially and educationally backward classes (O.B.C.) (non-creamy layer). This will increase the students strength considerably with the annual intake of 2445 in LL.B. and 106 in LL.M. courses. The total students strength is likely to go to more than 5000.

The unrelenting efforts of the faculty members in the revision of reading materials both for LL.B. and LL.M. degree courses in each semester during last three years has been un-paralleled. The Case Materials, question papers for LL.B. and LL.M. Entrance Tests for the years 2008 and 2009 along with answers, examination date-sheet, list of students admitted to first year of LL.B. and LL.M. courses have been put up on Delhi University website www.du.ac.in for the benefit of all concerned. This single step has brought not only transparency and accountability in the working of the Faculty of Law but the same has also been acclaimed as most beneficial for the students and teachers of other institutions of legal learning. While there is a general decline in the standard of quality education, this Faculty has not only maintained the existing high standards of legal education but it has also tried to raise it to further heights. With the adoption of uniform teaching and examination calendar by the University, there has been considerable increase in teaching time. This has led to more academic interaction between the students and teachers. The teaching and examination schedule announced in advance helps the students to properly plan their studies and vacations. With the strict enforcement of attendance rules, nearly 500 students each year are denied permission to appear in the examinations on account of shortage of attendance. Thus non-serious students have no place in this Faculty. With the adoption of one common examination for all students since 2007-08 and centralized evaluation system in December, 2008, the results are being declared within a very short time after conclusion of the examinations. The system has improved both the evaluation standards and results.



The Faculty of Law attracts students from abroad on account of its world-wide reputation. These foreign students come from highly developed and developing countries including United States of America, United Kingdom, France, China, Korea, Mongolia, Iran, Nepal, etc. They join LL.B., M.C.L. and Ph.D. programmes. During this year, two foreign nationals, one each from Korea and Iran, were awarded Ph.D. Degree on subjects such as Law of Partnership and Criminal Law. The student visitors for a limited period tudy included Ms. Li Lairu, Lecturer, Law Institute, Chinese Academy of Social Sciences and International Business School, Yunnan University of Finance & Economics and Ph.D. scholar visited the Faculty in March, 2010 to collect research and study materials on law of contract for her research work. Three students from France, viz. Ms. Clara Giraud, Jean-Baptiste Coquard and Penelope Bouchard, Exchange Students from Lyon III, France are presently studying at this Faculty from the beginning of the current academic year. They have been allowed to opt courses of LL.B. at their choice.

There has been tremendous increase in the visit of delegates from foreign countries during the academic year 2009-10. These included the visit of Prof. Dr. Rudiger Wolfrum, Director at the Max Planck Institute for Comparative Public Law and International Law, Dr. Walter Doralt, Max Planck Institute for Comparative Public Law and International Private Law and Prof. Dr. Ulrich Sieber, Max Planck Institute for Foreign & International Criminal Law, Freiburg, Germany in November, 2009. Prof. Debra A. Beauregard, Director of Graduate Program and Prof. Sharon Callahan, Director of Alumni Relations, Pierce Law, Franklin Pierce Law Center visited the Faculty on 16<sup>th</sup> November, 2009. Justice Elyakim Rubinstein of the Supreme Court of Israel visited the Faculty on 16<sup>th</sup> December 2009 and interacted with teachers and students regarding justice delivery system in his country. Woo, Yoon Keun, Yoon S. Chang and Park, Min-shik, Members, National Assembly of the Republic of Korea along with Park Kyongsig, Second Secretary, Embassy of the Republic of Korea visited this Faculty on 12<sup>th</sup> January 2010. Tri Hayati, Head of Undergraduate Extension Programme visited the Faculty in January, 2010 to explore the possibility of exchange programme between India and Indonesia. Prof. Dermot Cahill, Head of Bangor Law School visited the Faculty on 21<sup>st</sup> February 2010 and delivered a lecture on "Recent price fixing decisions of the competition authorities in Europe and the UK" in which the students and teachers closely interacted.

A delegation of 45 officers and members of courts, legislatures and other departments from 34 countries visited this Faculty on 28<sup>th</sup> January 2010. They included officers and members from Afghanistan, Argentina, Armenia, Bangladesh, Cambodia, Congo, Ethopia, Fiji, Guatemala, Indonesia, Iraq, Jamaica, Lithuania, Mauritius, Mongolia, Myanmar, Nigeria, Oman, Peru, South Africa, Sri Lanka, Sudan, Surinam, Swaziland, Tajikistan, Tanzania, Thailand, Tunisia, Uganda, Ukraine, Uzbekistan, Zambia and Zimbabwe besides officers from Indian Parliament and state legislatures. A similar delegation had visited this Faculty for the first time in January, 2009 also.

The most significant visit was from Moscow, Russia. Ms. Gracheva Elena, Vice Rector Kutafin Moscow State Law Academy and Ms. Sokolova Natalis, Vice Director of the Institute of Jurisprudence of Kutafin Moscow State Law Academy visited the Faculty on 27<sup>th</sup> February 2010 and entered into a Memorandum for Cooperation for joint activities including exchange of students and faculty staff, publications, teaching materials, information on educational and research activities and participation in conferences, symposia and seminars.

The Faculty of Law laid particular emphasis on environmental protection and legal aid programmes during the year 2009-10. One-day Legal Aid and Awareness Programme was organized at Vill. Gopalpur, Distt. Rohtak, Haryana on 21<sup>st</sup> February 2010 in which nearly 100 students of LL.B., LL.M. and M.C.L. along with teachers participated alogwith the villagers. The interaction related to acquainting the villagers about the fundamental rights and duties, right to information and consumer protection. Two environmental trips were taken to have on the spot study of the impact of various legislative and executive measures to prevent and control pollution of river Yamuna at Agra and Vrindaban on 24<sup>th</sup> March 2010 and river Ganga at Hardwar and Rishikesh from 26<sup>th</sup> - 29<sup>th</sup> March 2010. More than 45 students and teachers participated in the trip.

The students of this Faculty have excelled in moot court competitions held in India and abroad. Five students were selected to represent the Faculty of Law at the White & Case International Rounds of the 51<sup>st</sup> Philip C. Jessup International Moot Court Competition held in March, 2010 at Washington D.C.

During last three years, new prize, medal and scholarship have been instituted. They include "Justice Sunanda Bhandare Gold Medal in Family Law" to be awarded to a student of LL.B. securing highest marks in Family Law I and II Papers together and clears all papers in the first attempt; Fellowship of Rs. 1500.00 per month in the name of "Justice Sunanda Bhandare Fellowship in Constitutional Law" to be awarded to a student of LL.B. who secured highest marks in Constitutional Law I and II together and clears all papers in first attempt. The University of Delhi has also received donation of Rs.6,25,000/- for institution of Sohan Lal Sethi Memorial Scholarship to be awarded for securing highest marks in LL.B. I-V Term Examinations each year.

The Faculty expresses its deep sorrow on the sad demise of its four retired members. Prof. K.B. Rohatgi, a teacher of Mercantile Law, had headed this Faculty from 1971-75 and later became the Director, South Delhi Campus, University of Delhi. Dr. A.S. Bedi was an excellent teacher of International Law and Criminal Law and worked in this Faculty for a long time. Shri T.S. Batra served this Faculty for a number of years and taught International Law. Dr. Shobha Saxena had joined this Faculty relatively at a late stage of her academic career. The Faculty is greatly indebted to all these colleagues for their contribution to its growth.

The Faculty has a very bright future not only in terms of its expansion and infra-structure but also in providing leadership in the field of legal education in the country. Let every one - student, teacher, employee and alumni - contribute his/her best towards achieving the goal of excellence in legal education to maintain the leading role played by this great institution.

### IMPORTANT INSTRUCTIONS

Before filling the Application Form for the LL.B./LL.M. Entrance Test 2010, the candidates are advised to read the contents of this Bulletin of Information carefully and also consult the Delhi University Act, 1922 and the Statutes, the Ordinances, Rules and Regulations of the University of Delhi, which would be binding on them.

- The Faculty of Law has presently three Centres for LL.B. students: Campus Law Centre where classes are held from 8.30 a.m.; Law Centre -I where classes are held in the afternoon (3.00 p.m.-6.00 p.m.) and in the evening (6.15 p.m.-9.15 p.m.) and Law Centre-II where classes are held from 6.15 p.m.-9.15 p.m. The Campus Law Centre and Law Centre-I are located at the Faculty of Law (North Campus), Chhatra Marg, University of Delhi, Delhi-110 007 and Law Centre-II in A.R.S.D. College Building, Dhaula Kuan, New Delhi-110 021.
- 2. LL.B. Degree Course is a three-year full-time course and no student is permitted to pursue simultaneously any other course including any professional course like Chartered Accountancy, Company Secretaryship, etc. except a language course of the University of Delhi. The admission of a student is liable to be cancelled at any stage for violation of this rule. The Degree awarded may be withdrawn.
- 3. LL.M. Two-year Degree Course is a full-time course meant for those who are not employed or engaged in any trade, profession, business or occupation. At the time of admission to LL.M. Two-year course, the student shall submit an affidavit in the prescribed form to the effect that he/she is not employed or engaged in any other work. LL.M. Three-year course is meant for all.
- 4. The admissions to LL.B./LL.M. course will be made by the Admission Committee on the basis of merit in the Entrance Test 2010 held by the University of Delhi. The candidates must seek information relating to admissions only from the Admission Committee, Faculty of Law, University of Delhi, Delhi-110007.
- 5. The information given by an applicant in the application regarding category General, Scheduled Caste, Scheduled Tribe, O.B.C., Physically Handicapped or Widows/Wards of armed forces personnel shall be final and no change shall be permitted later on under any circumstances.
- 6. Furnishing of false, wrong or inaccurate information may lead to cancellation of the Test result, admission, examination, forfeiture of degree and even prosecution in appropriate cases.
- 7. Incomplete applications may be rejected and no correspondence will be entertained in this regard. The receipt of an application will not mean that the same is complete or the applicant is eligible to appear in the Entrance Test.
- 8. The fact that the candidate has been allowed to appear in the Test will not mean that he/she has a claim to admission unless he/she produces all the prescribed documents including those relating to eligibility in support of his/her claim and complies with all the prescribed requirements.
- A blind candidate cannot himself/herself engage a writer but would be provided a writer by the Faculty of Law. No extra time shall be allowed to him/her to complete the Test paper. All such candidates must clearly mention his/her visual handicap in the Application Form.
- 0. The result of the Entrance Test shall be notified on the Notice Board of the Faculty of Law. The result would also be available on the University **website: www.du.ac.in** All notices relating to admission, counselling, etc. shall be displayed only on the Notice Board of the Faculty of Law. No individual communication will be sent to any candidate for this purpose.
- 11. Once the admissions have been notified as closed after filling all seats, admissions shall not be re-opened.


The application for admission to LL.B./LL.M. Entrance Test 2010 must be made by eligible candidates on the prescribed application form. The Bulletin of Information along with the application form will be available from Monday, 05 April 2010 to Monday, 17 May 2010 from the office of the Admission Committee, Faculty of Law, University of Delhi, Delhi-110007 on submission of a bank draft of Rs. 700.00 (Rs. 250.00 for SC/ST candidates) drawn in favour of **Registrar, University of Delhi**. The application alongwith the Admission Ticket duly filled in by the candidate in his/her own handwriting and signed must be delivered in person or sent by post to the Admission Committee latest by 5.00 p.m. on 17 May 2010. In case the form is downloaded from website, the application must be accompanied with a bank draft of Rs. 700.00 (Rs. 250.00 in case of SC/ST candidates). The candidate must paste at the place indicated one self-attested recent passport-size photograph on the application and un-attested photograph on the Admission Ticket. No other document like marks-sheet(s), certificates, etc. need be sent along with the application since there will be no pre-Test scrutiny of the applications except in cases of doubt.

The candidate sending the application by post must enclose one self-addressed envelope of 25 x 11 cms. size bearing postal stamp of Rs. 10.00 for dispatch of the Admission Ticket.


The applications received by any means after the prescribed last date will not be accepted. The applications received by any person or authority other than the Faculty of Law, University of Delhi will not be considered. The candidate must ensure that his/her application reaches in time. The mere fact of sending/posting of an application prior to the last date prescribed for receipt of applications will not mean that the same has reached within the prescribed time unless the application has actually been received in the office of the Admission Committee, Faculty of Law.

The LL.B./LL.M. Entrance Test will be held at different examination centres located in Delhi. The candidate will be issued the Admission Ticket indicating Roll No. and the examination centre where he/she will be required to appear in the Test. If a candidate has lost the Admission Ticket or not received the same, he/she is advised to contact, in person, alongwith two recent passport-size photographs the office of the Admission Committee, Faculty of Law for duplicate Admission Ticket on 29 May 2010 during working hours for LL.B. Entrance Test and on 04 June 2010 for LL.M. Entrance Test. **No candidate will be allowed to appear in the Entrance Test without Admission Ticket.** The candidates are advised to preserve the Admission Ticket till the admissions are finalised and produce the same on every occasion while visiting the office of the Admission Committee, Faculty of Law. The permission to allow a candidate to appear in the Test will be governed by the provisions of this Bulletin of Information and all the relevant Statutes, Ordinances, rules and instructions of the University of Delhi with regard to his/her conduct during and after the Test.

#### Admissions as per merit in Entrance Test:

- Subject to other provisions of this Bulletin of Information, all admissions except those of (i) foreign nationals will be made strictly according to merit in the concerned category obtained in the LL.B./LL.M. Entrance Test 2010 keeping in view the preference of the Law Centre in case of LL.B. admissions and two-year/three-year course in case of LL.M. admissions given by the candidate at the time of counselling.
- (ii) Subject to production of an undertaking, provisional admission may be given to the candidates whose results of the qualifying Degree examinations have not been declared at the time of admission. The candidates given provisional admission shall be allowed to attend classes but no other right will accrue to them till their provisional admission are confirmed. All such admissions have to be confirmed before the date(s) notified by the Dean, Faculty of Law which will not be later than 15 October 2010 failing which the provisional admissions shall stand automatically annulled.

Note: (1) The candidates falling under any reserved category who are able to secure admission in the general category having fulfilled all the requirements of general category candidates will not be counted in the reserved quota.

- (2) If a candidate claims reservation under more than one category (SC/ST/OBC/PH/CW), he/she should indicate the relevant categories in the application.
- (3) Any vacant seat under ST category will be filled up from SC category and vice versa.
- (4) In case of candidates with more than one type of reservation, the reservation shall cut across the existing reservations of SC/ST/OBC; widows/wards of officers and men of armed forces in accordance with the principle of interlocking reservation. In other words, there will be subreservations for physically disabled candidates in each reserved category, thus a disabled SC/ST/OBC candidate would have preference over an ablebodied SC/ST/OBC candidate.
- (5) The reservation for OBC candidates shall be granted only on the basis of Central List.
- (6) Unfilled seats under any reserved category shall be offered to other eligible candidates.
- (7) Supernumerary seats, if vacant, shall not be offered to any candidate.



- The CMO, WUS Health Centre would constitute a medical board consisting of (a) medical specialists in the concerned field of disability. (b) rehabilitation experts and (c) Dean, Faculty of Law or his nominee. The Medical Board shall examine the candidates to determine the extent of disability on a 10-point scale and recommend the points to be added as weightage to the marks scored in the qualifying Degree examination for the purpose of admission. The Medical Board chaired by the CMO would function at the WUS Health Centre, Chhatra Marg (near Patel Chest Institute), University of Delhi and any additional Board, if required, at the WUS Health Centre, South Campus.
- 7. The Medical Board shall send all data on disability points awarded to each candidate to be displayed at the office of DSW. The recommendation would be sent directly to the Dean, Faculty of Law with a copy to DSW.


