Entry in Course Work Programme shall not ensure admission to Ph. D Programme.

**Reservation:** As per Govt. Rules.

# **INFORMATION SHEET**

Admission to Ph. D. Course Work Programme in Science, Arts, Commerce etc. for the year 2012-2013

#### General information to the candidates:

- (i) Candidates will be selected for admission to Course Work Programme through written test & or Personal interview as the case may be.
- (ii) The mere fact that a candidate, having the minimum qualifying marks in the written test, will not , by itself, ensure his/her admission to the programme.
- (iii) All qualified candidates in the written test will be required to appear at the interview test and will have to pursue course work, if selected.
- (iv) A candidate, securing minimum qualifying marks in the written test, will be formally called for appearing before the concerned Research Advisory Committee for interview.
- (v) If the concerned Research Advisory Committee is satisfied that the candidate is fit for undergoing the research work in the proposed area, his/her name will be recommended to pursue course work, the decision of which in this regard shall be final.
- (vi) No candidate, except J.R.F. or S.R.F., State Funded fellow/UGC Fellow will be entitled to fellowship money. He/she will have to carry on the course work, research work at his/her own expense under prescribed norms & conditions which will be intimated in due course.

#### Mode of selection:

For selection at the Ph. D. course work, a candidate has to obtain minimum qualifying marks of 50% or as may be determined by the appropriate authority at the written test. Qualified candidate, at the written test, be compulsorily required to appear at the interview test & must obtain minimum 50% marks or as may be determined by appropriate authority and will have to pursue Course Work.

#### Who are exempted from appearing at the written test:

The candidate who have an M.Phil./M.Tech./M.S./L.L.M./M.C.A. or a Degree deemed equivalent having at least 6 years of Under-graduate and Post-graduate studies, or who have qualified in the NET/SET/GATE/SLET/UGC(JRF)/CSIR(JRF) or any other examinations that may be deemed equivalent by the appropriate authority or Teacher Fellowship holder are exempted from appearing at the written test for Ph. D. course work Programme.

## Where to submit the prescribed application form:

All the application forms under the Faculties of Arts and the Science are to be submitted to the respective Office of the Faculty Council at Rajbati Campus, Burdwan University.

## What to enclose with the forms:

Candidates must enclose with the form duly attested photo-copies of mark sheets of all the public examinations passed by them up to the Masters/ Post Masters level and S.C.\*/S.T.\*/P.H.\*\* certificate, if any, by the last date of submission of application form.

#### Issue of Admit Card:

The applicants will be required to collect Admit Cards from the Office of the concerned Faculty Council at time of submitting the application forms.

- Relevant Certificate must conform to West Bengal Govt. Memo No. 1813-BCW/MR-94/11 dated 20<sup>th</sup> iune. 2001. Candidates claiming reservation against SC/ST quota of seats must submit relevant caste certificates issued in their favour by one of the authorities listed below:
- (i) Deputy Collector of Land Revenue, Kolkata Collector of Stamp Revenue, Kolkata Metropolitan Magistrate, Kolkata, Addl. Chief Metropolitan Magistrate, Kolkata, Chief Metropolitan Magistrate, Kolkata, 1st Class Stipendiary Magistrate, Executive Magistrate, Sub- Divisional Magistrate, Sub-Divisional Officer, Deputy Collector, Addl. District Magistrate, Collector and District magistrate within their respective jurisdictions in case of candidates claiming to be Schedule Caste or Schedule Tribe and ordinarily residing within such iurisdictions.
- (ii) Deputy Director, Backward Classes Welfare, West Bengal and Commissioner, Backward Classes Welfare, West Bengal in the case of candidates claiming to be Schedule Caste or Schedule Tribe residing in any part of W.B.
- \*\* The Certificate must be currently renewed and issued in the favour of the candidate by an appropriate authority not below the rank of Superintendent of Sub-Divisional Hospital. In the certificate, the extent of Physical Disability must not be below 40% Such candidates who claim reservation against this quota must also personally appear before the Medical Board constituted by the University on a specific date, time and place to be informed later for determining their eligibility of admission in this quota.
