

Christ University is administered by its founders Carmelites of Mary Immaculate (CMI). Blessed Kuriakose Elias Chavara, a visionary educationist and social reformer of the nineteenth century founded the CMI congregation in 1831.

Christ University was formally established in July 1969 as Christ College under Bangalore University. The University Grants Commission conferred Autonomy to Christ College on October 7, 2004. It became the first College in South India to be reaccredited with A+ by National Assessment and Accreditation Council (NAAC) in May 2005. The UGC identified it as an Institution with Potential for Excellence. On July 22, 2008 the Ministry for Human Resources Development, Government of India, under Section 3 of the UGC Act, 1956 declared Christ College as a Deemed to be University in the name and style of Christ University.

Christ University, a premier educational institution, is an academic fraternity of individuals dedicated to the motto of Excellence and Service. The University welcomes students from all over the world to an environment of religious harmony and secularism.

School of Law

The School of Law offers Undergraduate, Postgraduate and Doctoral programmes in law as per the guidelines of the Bar Council of India and the University Grants Commission. It has a flexible curriculum offering several options in different areas of specialization. It is devised keeping in mind the requirements of legal profession and academia.

The programmes offered at the School of Law incorporate a number of special opportunities such as internships, clinical programme, supervisory research and writing. In order to promote interaction between students and legal professionals, seminars, guest lectures and workshops are conducted on various subjects of law at regular intervals. In addition to the mandatory courses spanning across a tensemester programme, the school of law has also introduced numerous other value-added courses and programme for the benefit of its students.

The School of Law has well-equipped infrastructure. The entire campus is WiFi enabled. The students have access to three different library facilities, namely the general library, the specialised law library and the online library. Along with 160,000 books and 497 journals and periodicals, the general library also has a good collection of audio and videotapes for educational purposes. The specialised law library has over 23,000 books and 6,500 reports. It has subscribed to over 90 journals and 14 online resources such as Manupatra, Westlaw, Hein Online, JSTOR, Lexis Nexis, EBSCO and Proquest research library.



ADMISSIONS 2012 BA, LLB (Hons.) and BBA, LLB (Hons.)

- A pass in Class 12 (10+2)/ PUC or equivalent with a minimum of 45% marks in the final examination is required, to be eligible to appear for the entrance exam to be conducted on May 06, 2012. The entrance exam is followed by a micro presentation and a personal interview.
- The candidates should also be below the age of 20 years as on July 01, 2012.



LLM (Corporate Law) and LLM (Intellectual Property Law)

 A candidate who has passed LLB (3 or 5 year course) with a minimum of 50% is eligible to appear for the entrance exam. The entrance exam is followed by a personal interview.

MPhil

• A candidate who has passed LLM with a minimum of 55% in any discipline is eligible to appear for the entrance exam. The entrance exam is followed by a personal interview.

PhD

A candidate who has an LLM with a minimum of 55% marks awarded by any University recognized by the UGC / Indian Association of Universities is eligible to appear for the entrance exam. The entrance exam is followed by interviews.
