The human fetus from a month old till its mature stage & other rarities such as cysts & tumors removed from the body, are all on display making it a veritable bank of visual reference.

Hi-tech laboratories

The vast expanse of Medical Science and its complexity, necessitate that constant experiments and case studies be conducted within well equipped laboratories. The college has an array of modern laboratories with state of the art equipment. Trained laboratory-staff provide proper assistance and guidance to the students under faculty guidance.

Dept. of medical education

Advances in health science and changing social structure of the country have necessitated need for modernity and validity of medical education. The DOME of J.N. Medical College has been recognized by the Medical Council of India, New Delhi, as one of the Regional Centers to train Medical faculty in 'Medical Education Technologies' and have been assigned faculties of 15 medical colleges of North Karnataka for training (vide MCI letter No. MCI-Academics/2011/24 dated 01.04.2011).

Additionally at University level there is University Department of Education for Health Professionals (UDEHP), which carries out the following activities:

- a) Training of trainers: Conducts in house workshops on educational technology and behavioral sciences.
- b) Undergraduate Medical Education: Organizes workshops for formulating syllabus, curriculum and evaluation and orientation programs for UG students.
- c) Postgraduate Medical Education: Conducts Orientation Programs to give an insight into research methodology, planning, execution and to train PG students in communication skills.
 - d) Training for Health Professionals.

National & international collaborations

The College is in collaboration with National & International bodies/ Universities of France, USA, etc. such as ICMR, WHO, University of Illinois Chicago, (USA), University of Missouri Kansas City (USA), Gift of Life (USA), Smile Train project amongst others.

Public - private partnership

The 3 Rural Primary Health Centres (Viz., Kinaye, Handiganur and vantamuri) and 3 Urban Health Centres (Viz., Ashok Nagar, Ram Nagar and Rukmini Nagar) of Belgaum have been handed over to J.N. Medical College under 'Arogya Bandhu Scheme' by Government of Karnataka through its order No. AKK. 270. AYS. 2000 dated 8th March 2002 and No. AKK. 33. CGM. 2011 dated 30th September 2011, respectively, delegating total administrative control of all these centers to the Principal J. N. Medical College, Belgaum.

The teaching hospital wherein the patients get free treatment including free stay, free food, free medication, free operative procedures, free doctor & nursing care. All the national health programmes are implemented like Family Welfare Scheme, Voluntary Counselling & Testing Centre (VCTC); Prevention of Parent to Child Transmission of HIV/AIDS (PPTCT); Revised National Tuberculosis Control Programme (RNTCP) etc. In additions, the most prestigious 'Bal Sanjeevini' scheme of Government of Karnataka has been given to our hospital wherein the children below the age group of 0-6 years get all free treatment with the expenses up to Rs. 50,000/-. J. N. Medical College is one of the only five Centres recognized by Government of Karnataka.

Convocation & award of degree

MBBS / BDS students after passing final MBBS examination and undergoing compulsory rotatory internship to the satisfaction of concerned College or University authorities shall be eligible to receive MBBS/BDS degree.

Registration with MCI / DCI

Students will have to take temporary registration during internship & soon after completion of internship; they have to apply for permanent registration with Karnataka Medical Council / Karnataka Dental Council and practice there after registering with respective State Medical Councils / Dental Councils where they intend to practice.

Eligibility for appearing in KLEU-AIET – 2012 & subsequent admission

4. **Common Eligibility Requirements for admission to MBBS/BDS:** Only those candidates who would satisfy or are likely to satisfy the relevant eligibility requirements for admission to a course will be considered eligible to appear for the KLEU All India Entrance Test (KLEU-AIET – 2012) & subsequently for admission to that course.

4.1 Age:

The candidate shall complete 17 years of age on or before the 31st December 2012.

4.2 Qualifications:

For MBBS: As prescribed by the Medical Council of India.

For BDS: As prescribed by the Dental Council of India.

Note:

- **a.** For candidates seeking admission to MBBS course, the candidate should have scored minimum 60% marks in the subjects of Physics, Chemistry and Biology taken together in the qualifying examination. i.e. XIIth /PUC II/ 10+2/ HSC / equivalent examination. The candidate should also have scored 50% marks in English language in the qualifying exam.
- **b.** Candidates who are likely to appear or who have appeared for qualifying examination i.e., PUC II/10+2/HSC or equivalent but whose results have not been declared will also be considered eligible to appear for KLEU-AIET-2012, provided they have offered the above mentioned subjects at the said examination.
- c. The candidates who have passed the qualifying examination (XIIth /PUC-II/10+2/HSC/ B.Sc.- Degree/ first year of three year degree course as specified by Medical Council of India to be considered as eligibility for appearing in entrance test) earlier than 2010 are not eligible for applying to KLEU-AIET-2012 for seeking admission to MBBS course.
- d. Eligibility criteria for courses other than MBBS and BDS is provided at annexure 'A' of the brochure.
- e. Candidate should have passed qualifying examination from a board recognized by the Ministry of Human Resource Development (MHRD), Govt. of India.

5. Application procedure:

6. Instructions for completing the Application Form

M.Pharm / MPT / M.Sc. (N) / MD Ayurveda there is a separate common application form. No separate form is prescribed for any particular course or college. The candidates should avoid overwriting, cutting, erasing on the form. Any discrepancies in the statements and /or submission of incomplete form will lead to its rejection/ cancellation of admission.

- 6.1 The candidate should choose only one centre and indicate clearly the examination centre at which he/she wishes to appear for examination by ticking the appropriate one.
- 6.2 A Photograph taken as per specification mentioned in **Rule 58**, should be Pasted and attached to printed copy of application form submitted online.
- 6.3 The declaration in the online application form is to be signed both by the applicant and the parent /guardian of the applicant, on the downloaded printed copy.

7. CANDIDATES ARE NOT REQUIRED TO ENCLOSE ORIGINALS OF ANY CERTIFICATES WITH THE APPLICATION FORM.

7.1 The candidates should invariably mention their name and the number of the application form (as printed on it) on the back of the Demand Draft.

- 7.2 The applications must be sent by registered post/speed post/ courier.
- 7.3 The application must reach either by hand or by post to the above address on or before 23th April 2012 by 5:00 p.m.

An incomplete application KLEU-AIET-2012 form & an application form which is not accompanied by a demand draft of the prescribed KLEU-AIET-2012 fee of Rs. 1,500/will not be entertained & processed. This fee should not be sent by money order. **Please note that this fee is non-refundable.**

- 8. This University will not be responsible for any delay or loss of the Application / Admission Card/ Counseling Letter/ any other communication in transit. Such a delay will not be condoned.
- 9. The applicant himself/herself has to ascertain from the university office whether his application has reached to the university office or not.

10. Issue of Test Admission Tickets (TAT Cards):

- TAT cards can be downloaded by the candidates from the University Website w.e.f.
 Thursday, 26th April 2012
- The TAT Card will indicate the Roll Number & Examination Centre allotted to the candidate with its address.
- 11. The candidate must not mutilate this TAT Card or Change any entry, made therein after the university authorities have authenticated it.
- 12. In case a candidate does not receive the TAT Card (Hall Ticket) by 2nd May 2012, he/she should contact University office immediately. Arrangements will be made for the issue of duplicate TAT Cards at the 'Help Desk' established on previous day (i.e 4th May 2012) at respective examination centers. In such a situation, candidate should bring two identical copies of his / her photographs which is affixed to application form along with his / her proof of submission / posting of online printed application form or school/college identity card or photocopy of the submitted application form. In case no proof is submitted duplicate TAT card will not be issued.

Conduct of KLEU-AIET -2012:

- 13. The examination will be conducted at the different cities in the designated examination centers from 02:00 PM to 5:00 PM for UG Courses and 02.00PM to 4.00PM for PG Courses on 5th May 2012. The candidates must report at the centre at least 30 minutes before the scheduled time of commencement of the test.
- 14. THE EXAMINATION HALL WILL BE OPENED 30 MINUTES BEFORE THE COMMENCEMENT OF THE TEST. CANDIDATES ARE EXPECTED TO TAKE THEIR SEATS AT LEAST 15 MINUTES BEFORE THE COMMENCEMENT OF THE EXAMINATION. IF THE CANDIDATES DO NOT REPORT IN TIME, THEY ARE LIKELY TO MISS SOME OF THE IMPORTANT INSTRUCTIONS WHICH WILL BE ANNOUNCED IN THE EXAMINATION HALL.
- 15. Special procedures to authenticate the identity of students will be undertaken, and students are bound to cooperate.
- 16. Candidates will not be allowed to appear for the test if he/she is late by 30 minutes or more to reach the examination hall.
- 17. The Candidates must bring TAT card & show the same on demand for admission to the examination hall. A candidate who does not have the TAT card issued by the KLE University, will not be admitted to the examination hall under any circumstances by the Centre Superintendent.
- 18. A seat with a number will be allotted to each candidate in the examination hall.
- 19. The candidates will not be allowed to carry any textual material, printed or hand written chits or any other material except the TAT Card inside the examination hall. Candidates will not be permitted to bring calculators, slide rules, clerk tables, and electronic watches with facilities of calculators, laptop computers, personal stereo systems, walkie-talkie set, paging devices, mobile telephones and any other objects/devices in the examination hall. Possession or use of such devices during the examination is prohibited & candidate is liable to be expelled if found using or possessing them.
- 20. Parents, relatives or friends of the candidates will not be allowed to enter into the premises of the examination centres. No arrangement will be made for tea, snacks etc. for the students or parents.
- 21. Candidates are advised to bring with them a card board or a clip board, on which nothing should have been written. This board will be useful to them while writing their responses in the answer sheet, in case tables in the examination hall do not have smooth surface.

- 22. Candidates should maintain perfect silence & discipline in the examination hall. Any conversation, gesticulation or disturbance in the examination hall shall be considered as misbehavior & the candidates involved in such behavior will be expelled from the examination hall. Similarly, if any candidate is found using unfair means or allowing someone else to impersonate him/ her, his/her candidate at the examination will be instantaneously cancelled and the matter informed to the nearest police station.
- 23. Smoking in the examination centre is strictly prohibited. Beverages or snacks of any kind are not allowed to be taken into the examination halls during examination hours.
- 24. During the test time, the invigilator will check the TAT Cards of the candidates to satisfy himself/herself about the identity of each candidate. The invigilator will also put his/her signature in the place provided in the Answer Sheet.
- 25. After completing the test & before handing over the Test Booklet & Answer Sheet back to the invigilator, the candidate should check once again to see whether all the particulars required in the Test Booklet & the Answer Sheet have been correctly written. He should ensure that the TAT Number, Centre Code & the Test Booklet number are correctly written on the answer sheet.
- 26. A warning bell will be given at the beginning of the test & also to mark the half-time of the test time. A bell will also be given at the closing time when the candidate must stop marking the responses or writing.

Mode of the Test:

27. For UG Courses the test will have 200 multiple-choice questions (MCQs) of single best answer type on Physics, Chemistry, Botany & Zoology (50 on each of them). For PG Courses the test will have 100 multiple choice questions (MCQs) based on the syllabus prescribed by Regulatory Councils for the respective Under- Graduate Courses viz. B.Pharm, BPT, B.Sc Nursing, BAMS.

The time allotted will be 180 minutes (3hrs) and 120 minutes (2hrs) for UG and PG Courses respectively. The test will begin at 2.00pm.

Candidates are required to mark their answers in an ICR (Intelligent Character Reader) Answer Sheet.

Each correct answer is awarded one mark.

There is no Negative Marking for wrong answers.

KLE-AIET - 2012 Syllabi

UG Courses:

The test paper in Physics, Chemistry, Biology includes questions based on the 10+2 syllabus followed by major 10+2 Boards/Universities. For PG Courses the questions will be from the syllabus as prescribed by Regulatory Councils for the respective Under- Graduate Courses viz. B. Pharm, BPT, B.Sc. Nursing, BAMS.

Test Booklet:

- 28. The candidate will be provided with a sealed Test Booklet with an answer sheet. The candidate will write with ball point pen blue or black, the required information regarding: TAT Number, Name, Test form number & Centre of examination & Test Booklet number in the columns on the answer sheet. He should also write information on the front page of Test Booklet without opening the seal. The candidates are advised not to open / break the seal of the same before they are instructed to do so by the invigilator.
- 29.In the Test Booklet, there will be 200 and 100 items/questions serially numbered for UG and PG Courses respectively. Each item question will be followed by four responses, marked (A), (B), (C), & (D).Out of these four responses, only one will be correct which needs to be selected &marked on the answer sheet.

The Answer Sheet:

- 30. An answer sheet will be given to the candidates along with Test Booklet at the time of the test.
- 30.1 This answer sheet will be of special type which will be scanned mechanically by Intelligent Character Reader. So the candidate should handle the answer sheet very carefully.

There will be two sides of the answer sheet.

30.2 Side 1-

This side of the answer sheet begins with instructions for marking the responses. The following information is to be filled in with a blue or black ball point pen only, neatly & accurately.

Signature and Left Thumb Impression of the Candidate

This side of the answer sheet also contains the following columns which are to be written / filled in with blue/black ball point pen only.

TAT Number : Write in the squares & darken (completely filling in) the appropriate circles corresponding to TAT Number.

Test Booklet Number: Each test booklet has a number. Write it at appropriate place.

Test Form Number: Write in the squares & darken the appropriate circles corresponding to Test Form Number mentioned on the Test Booklet.

30.3 Side 2 -

This side is to be used for marking responses to questions numbered 001 to 200 and 001 to 100 for UG and PG Courses respectively, after every question number, four circles numbered (A), (B), (C), & (D) are provided for this purpose

The candidate must indicate his/her response to the question by darkening the appropriate circle completely with any one of the following;



If the candidate darkens more than one circle or if he/she does not mark his response as shown above & marks his/her response as shown below, his/her response will be treated as wrong & will not be given marks.



- 31. The candidates are advised to decide about the answer before they mark it on the answer sheets. He/she must ensure that the circle is completely darkened. A lightly or faintly darkened circle is a wrong method of marking & will be rejected by the Optical Scanner.
- 32. If the candidate does not want to attempt any particular question he/she is advised not to touch any of the circles given against that question.
- 33. The candidate must not fold the answer sheet & should not make any stray marks on it.
- 34. A specimen copy of the answer sheet is given in printed brochure. Candidates are advised to go through it & get conversant with it. The candidate will learn from this answer sheet as to how to fill in the information asked for & how to mark the answers. This will help the candidates to do the things correctly & save their time.
- 35. The candidate must bring his/her own materials such as blue or black ball point pen/HB pencil. In case any pencil other than HB pencil is used, the answer sheet will be possibly rejected by the Optical Mark Scanner.

Important Instructions for marking:

Rough work:

41. The candidate will not do any rough work or writing work on the answer sheet. All rough work is to be done in the Test Booklet itself.

Answer Sheet:

All answers need to be registered on a machine-readable ICR sheet, which is machine read and evaluated. The Test Takers / candidates must use only blue or black ballpoint pen or HB Pencil for marking their answers on the ICR sheet.

ICR answer sheets will be supplied only at the examination hall. After the test is over, the answer sheet along with the test booklet should be given back, before leaving the room.

Kindly note that the candidates must sign and affix Left Thumb Impression on their TAT and ICR answer sheets in the presence of the invigilator, after the invigilator has verified their TAT Cards. Invigilators will also sign on the column indicating Invigilators Signature, if not, the answer sheet will be invalid and not be considered for processing.

Candidates are also required to write their names, and the question Booklet number in the space provided in their ICR answer sheet.

The ICR answer sheet is machine assessed and therefore it should be handled with care. If there is any doubt, please contact the test invigilator immediately.

The KLEU-AIET - 2012 test administration is timed. The test session is designed to be completed within 180 minutes, 120 minutes for UG and PG Courses respectively. as indicated in this brochure and no compromise will be made on the set time limits. The Chief Superintendent of the test centre is the official timekeeper. Candidates (Test takers) will not be permitted to continue the test beyond the established time limit.

Merit List:

- 42. The University will prepare a merit list amongst the candidates who have appeared for KLEU-AIET 2012 in accordance with the total marks obtained by them in Physics, Chemistry, Botany & Zoology taken together in it for admission to undergraduate courses. The candidates will be called for counseling as per their ranking in this list.
- 43. Copy of merit list will be displayed at the office of KLE University in Belgaum. The date of announcement of merit list shall be notified through official website of the University.

- 44. In case two or more candidates obtained equal marks in the KLEU-AIET-2012, the inter-se-merit of such candidates shall be determined in order of preference as under:
- 44.1 Candidates obtaining higher marks in Biology (Botany & Zoology) in the entrance examination, if equal.
- 44.2 Candidates obtaining higher marks in Chemistry in the entrance examination, if equal.
- 44.3 Candidates obtaining higher total marks in subjects of Biology, Chemistry, Physics in the 12th standard qualifying examination. (Such a tie will be settled at the time of counseling), if equal.
- 44.4 Candidates obtaining higher percentage of marks in the 10th standard examination, if equal.
- 44.5 The age of the candidate, (the elder candidate is ranked higher than the younger candidate).
- 44.6 In case of tie at this level, computerized random selection of candidate will be carried out.

Counseling & on-the-spot-admission session:

- 45. The counseling sessions will be conducted at KLE University, J.N. Medical College Campus, Nehru Nagar, Belgaum -590 010. The dates will be displayed on the University website later. FAILURE TO REPORT FOR COUNSELING ON THE SCHEDULED DATE AND TIME WILL RESULT IN INSTANTANEOUS CANCELLATION OF THE CLAIM OF THE CANDIDATE TO ANY SEAT. It shall be candidate's responsibility to see the result of KLEU-AIET 2012 on the University website.
- 46. The candidate should remain present for the counseling & for on-the-spot-admission, as per the schedule displayed on website, even though he/she fails to receive any information letter, for any reason from the University.
- 47. Only the candidate & one of his parents / guardian will be allowed into the hall where counseling is held. The candidates will be called in the order of their ranking in the merit list & offered the seats to the various courses available at that point of time. The candidate will be allowed to choose admission to any of the courses if a seat is available when his/her turn comes.
- 48. The candidate must note that appearance for the examination & inclusion of name in the Merit List does not necessarily mean that he / she will get admission to any course. His admission to a particular course will depend upon the availability of seats for that particular course at the time of his counseling.
- 49. At the time of reporting for the counseling, the candidate is required to produce the documents (original & two sets of photocopies) listed in Annexure I. If the candidate is admitted to any of the courses, these documents will be retained by the University till he/she completes the course. If the candidate fails to produce all or any of the documents listed in Annexure -I, he/she will instantaneously forfeit his/her claim for a seat.

- 50. The candidates in the merit list prepared on the basis of marks obtained by them at the KLEU-AIET 2012 will be called as per their ranks for counseling & on the spot admission to the various courses & colleges.
- 51. If any candidate finds it impossible to be physically present for the counseling due to unavoidable circumstances, he/she may authorize any other responsible individual to represent him/her at the counseling. This representative must carry with him/her the letter of authorization in the format given in Annexure III as well as all the documents listed in Annexure I. If the candidate or his representative fails to report for the counseling on the date & time mentioned in the schedule of counseling, his/her claim for the seat will be forfeited. The choice of course made by the candidate, his/her representative will be final & binding & will not be ordinarily altered later. The Candidate must report physically to the University office, within 72 hrs of the allotment of a seat if authorized representative has appeared for the counseling.
- 52. The selected candidate will be required to pay the entire amount of annual fee on the day of counseling itself. (Through Bank Draft drawn from the nationalized banks in the name of Registrar, KLE University payable at Belgaum). In case the candidate fails to remit the entire amount of fees, he/she is likely to lose his/her claim for admission to that seat.

University's Policy against the Ragging in accordance with the directions of Hon. Supreme Court of India, UGC and other Regulating bodies.

The KLE Academy of Higher Education and Research, Belgaum and its all Constituent Units takes most stringent view against any act of Ragging and all the prospective students are warned against indulging in any act and / abetment of ragging and their Guardians are advised to sensitize and advise their wards against the same, which may lead to most severe punishment including the initiation of criminal proceedings.
