5. Candidates are allowed to submit only one Application form. More than one application i.e. multiple Applications from a candidate will be rejected.
6. The name of the candidate and his/her parent's name in the Application form **must exactly be the same** as registered in class I.Sc./10+2/equivalent qualifying Examination. No prefix/title such as Mr/Shri/Fr/Dr/Mrs/Smt/Col etc should be used.
7. ***Application fee once paid will not be refunded (full or partial) under any circumstances.***
8. No options can be changed at a later stage after submission of an application.
9. Those candidates who are applying through ONLINE mode need not require to send the hard copy of application. However, the candidates are advised to retain hard copy of application i.e. confirmation page for future reference, counselling purpose or

correspondence, if any. But if any candidate applying through other than ONLINE mode, have to submit the filled up application form within the last date.

10. **The Jharkhand Combined Entrance Competitive Examination – 2016 will be conducted in one stage.**
11. The offer of admission shall be subject to verification of Original certificates/documents, identity at the time of counselling. **If any candidate is found ineligible at a later date even after examination, his/her candidature will be cancelled.**

JHARKHAND COMBINED ENTRANCE COMPETITIVE EXAMINATION – 2016

1. INTRODUCTION

In compliance with the J.C.E.C.E. Board Act & requisition received from the concerned Departments of Govt. of Jharkhand, the Jharkhand Combined Entrance Competitive Examination Board would be conducting the Jharkhand Combined Entrance Competitive Examination - 2016, for the academic session 2016-17. This entrance test is being conducted for the admission in first year degree level professional courses like Engineering, M.B.B.S., B.D.S., B.Sc. Agriculture, B.Sc. Forestry, B.V. Sc. & A.H., B.H.M.S. & other same type of courses within the Jharkhand State or outside of the State Universities/Colleges/Institutions where there is need of recommendation to state, recommendation will be based on Merit-cum-Choice basis prepared from J.C.E.C.E. – 2016 Merit List.

2. DEFINITIONS

- a. **“Professional Courses”** means Engineering, M.B.B.S., B.D.S., B.Sc. Agriculture, B.Sc. Forestry, B.V. Sc. & A.H., B.H.M.S. etc or any other courses of similar type which is of Degree Level.
- b. **“Examination”** means Jharkhand Combined Entrance Competitive Examination conducted by JCECE Board.
- c. **“Board”** means Jharkhand Combined Entrance Competitive Examination Board i.e. J.C.E.C.E. Board
- d. **“Government”** means Government of Jharkhand.
- e. **“Controller of Examination”** means Controller of Examination, J.C.E.C.E. Board, appointed by Govt. of Jharkhand.
- f. **“Jharkhand”** means Jharkhand State after reorganization as defined in section-3 of Bihar Re-organization Act – 2000.
- g. **“Qualifying Examination”** means that examination on the basis of which a candidate is eligible to appear in Jharkhand Combined Entrance Competitive Examination.

3. GENERAL INSTRUCTIONS

- (a) Jharkhand Combined Entrance Competitive Examination will be governed by the rules and regulations specified by the Jharkhand Combined Entrance Competitive Examination Board, Ranchi, All India Council of Technical Education, New Delhi, Medical Council of India, New Delhi, Veterinary Council of India, New Delhi, Dental Council of India, New Delhi etc.
- (b) Appearance in J.C.E.C.E. - 2016 does not confer any right to the candidate for admission in Degree Courses. The selection and admission to B.E. / B. Tech / M.B.B.S. / B.D.S. / B.Sc. Agriculture / B.Sc. Forestry / B.V.Sc. & A.H. / B.H.M.S. seats in any Institution is subject to fulfilling the admission criteria, eligibility, medical fitness and such other criteria as may be prescribed by the Government, respective Universities, respective council and Technical Institutions.
- (c) Applications of candidates submitting false and fabricated information will not be considered.
- (d) Incomplete application or applications not in accordance with instructions will not be considered and are liable to be rejected. **The examination fee deposited will not be refunded in such cases.**
- (e) Fee once paid will neither be carried forward to a future Examination nor could be refunded under any circumstances. Online applications and/or their confirmation of submission received after the due date will not be entertained and exam fee will not be refunded in such cases. Applications once submitted cannot be withdrawn.
- (f) Instructions in the Information Bulletin are liable to change based on decisions taken by the Board from time to time. There is no equity or any rights that are/or deemed to be arising in favour of candidates.
- (g) Board reserves the right to withdraw permission, if any, granted inadvertently to any candidate who is not eligible to appear in the J.C.E.C.E. – 2016 even though the Roll Number and Admit Card have been issued by the Board.
- (h) Candidate's eligibility is purely provisional and is subject to fulfillment of eligibility criteria as prescribed by the Board.
- (i) In case of any ambiguity in interpretation of any of the instructions/terms/rules/criteria's regarding determination of eligibility/conduct of

examination/registration of candidates/information contained therein, the interpretation of the J.C.E.C.E. Board shall be final and binding.

4. Subject Group for J.C.E.C.E. – 2016

- 4.1 P.C.M. Group** – A candidate who has passed/appearing in I.Sc / 10+2 or equivalent examination with subjects Physics, Chemistry and Mathematics and is interested in appearing in the Competitive Examination with Physics, Chemistry and Mathematics, then he/she will be called **PCM Group** and He/She will have to give answer the question of Physics, Chemistry and Mathematics subjects in the examination.
- 4.2 P.C.B. Group** – A candidate who has passed/appearing in I.Sc / 10+2 or equivalent examination with subjects Physics, Chemistry and Biology and is interested in appearing in the Competitive Examination with Physics, Chemistry and Biology, then he/she will be called **PCB Group** and He/She will have to give answer the question of Physics, Chemistry and Biology subjects in the examination.
- 4.3 P.C.M.B. Group** - A candidate who has passed/appearing in I.Sc / 10+2 or equivalent examination with subjects Physics, Chemistry and Biology as well as keeping Mathematics as an extra subject and is interested in appearing in the Competitive Examination with Physics, Chemistry, Biology and Mathematics, then he/she will be called **PCMB Group** and He/She will have to give answer the question of Physics, Chemistry, Mathematics and Biology subjects in the examination.

ii) Scoring and Marking

(a) Each question carries 1 mark. For each correct response the candidate will get 1 mark. For each incorrect response, $\frac{1}{4}$ marks will be deducted from the total score. No deduction from the total score will, however, be made if no response is indicated for a question in the answer sheet. The candidates are advised not to attempt such question in answer sheet, if they are not sure of the correct response. More than one answer indicated a question will be deemed as incorrect response and will be negatively marked.

(b) For the purpose of evaluation, the Question Booklet code as printed in the OMR Answer Sheet on side-2 will be accepted as final.

iii) Language of the Question Papers:-

- Question Paper consists of both **English** and in Hindi language.
- In case of any ambiguity in translation of any of the questions, its English version shall be treated as final.

6. DATE & TIMING OF ENTRANCE TEST

Jharkhand Combined Entrance Competitive Examination (J.C.E.C.E.) - 2016 will be

conducted on **Sunday the 05.06.2016**. The subject-wise timing & duration of examination are as follows:-

7. SYLLABUS FOR THE TEST:

The Question Papers for the Examination shall be based on a common syllabus notified by the CBSE. Please see Board's website for syllabus.

8. CENTRES FOR ENTRANCE TEST

- (i) List of district headquarters town where the **J.C.E.C.E. – 2016 (PCM Group)** will be conducted are Ranchi, Jamshedpur, Dumka, Dhanbad, Hazaribagh and Bokaro. **J.C.E.C.E. – 2016 (PCB & PCMB Group)** will be conducted only at Ranchi.
- (ii) The Candidate should select **Two Convenient town** for the entrance Test.
- (iii) Though every effort will be made to allot a centre in one of the towns selected by the candidate, yet the Board reserves its discretion to allot a centre other than the candidate's choice.
- (iv) Allotment of centre is made by Computer and there is no human intervention.

9. Use of Calculator and communication Aids

Use of electronic devices like mobile phone, calculator etc. is **NOT PERMITTED** in Examination. Materials like log table, book, notebook, etc. should **NOT** be brought into the examination hall.

10. ELIGIBILITY

10.1 Residential Criteria

The applicant must be a citizen of India and Local/Permanent resident of Jharkhand. The policy determination for issuing Local Resident certificate for admission in Educational Institutes has been laid down in the notification Memo No. 5/vividh –

09/2001(Domicile) Ka. 2691/Ranchi dated 29/4/02 of “Personnel, Administrative Reforms and Rajbhasa Department”, Govt. of Jharkhand. The Notification copy is available on the home page of Board's website under Downloads column.

A candidate will have to submit/show Permanent or Local Resident certificate in proper format in ORIGINAL at the time of counselling, issued by competent authority [Sub Divisional Officer – (Civil) or Dy. Commissioner of Jharkhand State]. The Residential certificate issued by any other authority will not be considered and his/her claim will be refused.

10.2 Educational Criteria

- **Engineering** – The candidate must have passed I.Sc. / 10+2 or equivalent examination with Physics and Mathematics as compulsory subjects along with Chemistry subject AND has obtained at least 45% marks (40% in case of candidate belonging to reserved category) in the above subjects taken together.
- **M.B.B.S. / B.D.S.** – The candidate must have passed I.Sc. / 10+2 or equivalent examination with the subjects of Physics, Chemistry, Biology and English individually and must have obtained a minimum of 50% marks taken together in Physics, Chemistry and Biology at the qualifying examination (I.Sc. / 10+2) & J.C.E.C.E. – 2016. In respect of candidates belonging to reserve category, the marks obtained in Physics, Chemistry and Biology taken together in qualifying examination & J.C.E.C.E. – 2016 be 40% instead of 50% for General Candidates.

In respect of Physically Handicapped General candidates, the marks obtained in Physics, Chemistry and Biology taken together in qualifying examination & J.C.E.C.E. – 2016 be 45% instead of 50%. In respect of Physically Handicapped reserve category candidates it is 40%.

- **B.Sc. Agriculture & B.Sc. Forestry** – The candidate must have passed I.Sc. / 10+2 or equivalent examination with Physics, Chemistry along with Mathematics or Biology.
- **B.V.Sc. & A.H.** - The candidate must have passed I.Sc./10+2 with Physics, Chemistry, Biology and English and obtained 50% marks (40% in case of candidate belonging to reserved category) in aggregate of these subjects.
- **B.H.M.S.** – The candidate must have passed I.Sc. / 10+2 or equivalent examination with English Physics, Chemistry & Biology.

10.3 Age Limit Criteria

- B. Tech. – No maximum / minimum age limit
- M.B.B.S. / B.D.S. /B.H.M.S. - completed age of 17 years at the time of admission or will complete the age on or before 31st December of the year of his/her admission.
- B.Sc. Agriculture & B.Sc. Forestry – minimum 17 years and maximum 22 years as on 1st July 2016. (3 years age relaxation for SC/ST candidate in upper age limit)
- B.V.Sc. & A.H. – Completed age of 17 years at the time of admission or will complete the age on or before 31st December of the year of his/her admission.

10.4 Physical Criteria: - Medical Checkup of candidates recommended for admission in all courses will be done by the Board and/or Institution and after check-up, only fit candidate will be treated as eligible for admission.

11. Reservation

11.1 *Reservation on Caste Basis*

Up-to-date prevailing reservation policy of Govt. of Jharkhand will be followed in all courses of Govt. and Non-Govt. Institutes. But, candidates claiming against reserved seat will have to submit/show Caste certificate in proper format in ORIGINAL at the time of counselling, issued by competent authority [Sub Divisional Officer – (Civil) or Dy. Commissioner of Jharkhand State]. The caste certificate issued by any other authority will not be considered for claim of reservation and his/her claim for reservation will be refused and will be deemed to as General category [Ref. कार्मिक प्रशासनिक सुधार तथा राजभाषा विभाग, झारखण्ड सरकार के पत्रांक 7/आ0नि0-018-10/2003 का0 7072 दिनांक 30.12.2003]. **Format of Caste Certificate is available on Act & Circular column on the Board's website. As per Memo no. 10007 dated 29.08.2013 of Deptt. Of Administrative, Personnel Reforms and Rajbhasha, GoJ, candidates belonging to BC – I & BC – II, have to submit/show the Caste certificate which includes Creamy Layer factor at the time of counselling. Caste certificate produced by BC – I & BC – II candidates will be valid only if he does not belong to creamy layer & it should be mentioned in caste certificate. The caste certificate format is available under Downloads column on the home page of the Board's website.**

11.2 *Service Man Quota (SMQ) (only in Govt. Engineering Institutes)*

This facility will be given to only notify Army Personnel as per the guidelines in “A guide to Resettlement of Ex-Servicemen 1984”, Ministry of Defence and Directorate General Resettlement.

Following will be the priority sequence for preparation of Merit List under Service Man Quota:-

- a. Widow/wards of Defence Personnel killed in action.
- b. Wards of Serving Personnel and Ex-Servicemen disabled in action.
- c. Widow/wards of Defence Personnel who died in peace time with death attributable to Military Service.
- d. Wards of Defence Personnel disabled in peace time with disability attributable to Military Service.
- e. Wards of Ex-Servicemen and serving Defence Personnel who are in receipt of Gallantry Awards.
- f. Wards of Ex-Servicemen.
- g. Wards of Serving Defence Personnel.

11.3 *Reservation for Physically Disabled candidates*

Seats are reserved for Physically Disabled candidates. The criteria & percentage of physical disability is given course-wise below :-

<u>3.</u>	B.V. Sc. & A.H.	Up to 50% disability of lower limb.	
<u>4.</u>	B.Sc. Agriculture & Forestry	Minimum 40% disability in low vision or hearing impairment or locomotors disability/cerebral palsy.	

Physically disabled candidates will have to submit full size photograph as well as

CERTIFICATE OF DISABILITY issued by the Chief Orthopedics Doctor of the District Hospital / Civil Surgeon of the Jharkhand State at the time of counselling.

11.3 Tuition Fee Waiver Scheme (ONLY in Engineering Institutes)

As per All India Council for Technical Education, New Delhi, additional 5% of intake capacity seats of all approved Institutions are provided for Tuition Fee Waiver scheme. The seats will be allotted to those candidates whose Family Total Annual Income from all sources is less than ₹ 6 lakh under this provision. For this, he will have to essentially submit an INCOME CERTIFICATE issued by Sub Divisional Officer – (Civil) or Dy. Commissioner of Jharkhand State at the time of counselling. INCOME CERTIFICATE must be issued within current 1 year. All seats will be unreserved under this scheme or there is no relation with reservation for such seats and seats will be allotted on the basis of Merit-Cum-Choice.

राज्य के व्यवसायिक / तकनीकी शिक्षण संस्थानों में नामांकन में स्थानीय निवासियों को ही नामांकन की सुविधा प्राप्त होती है, जो संविधान एवं विधि सम्मत है, परन्तु नवगठित झारखंड राज्य में 'स्थानीय निवासी' पूर्ण रूप से परिभाषित नहीं होने के कारण कठिनाईयाँ आ रही हैं।

2. उपरोक्त संदर्भ में 'स्थानीय निवासी' को परिभाषित करने संबंधी प्रश्न माननीय राँची उच्च न्यायालय में डब्लू. पी. (पी.आई.एल.) संख्या-586/2002 में उठाया गया है, जिसमें अंतरिम आदेश पारित है कि राज्य सरकार इस संबंध में शीघ्र नीति निर्धारित करे।
3. 'स्थानीय निवासी' से संबंधित राज्य की स्पष्ट नीति निर्धारित करने के पूर्व कुछ राज्यों-यथा, मध्य प्रदेश, उड़ीसा, कर्नाटक, उत्तर प्रदेश एवं आन्ध्र प्रदेश-से उन राज्यों में लागू नीति से संबंधित सूचनाएँ एकत्रित की गईं एवं उनका तुलनात्मक विवेचन किया गया। इसी संदर्भ में झारखंड संयुक्त प्रवेश प्रतियोगिता परीक्षा पर्वद्वारा 'स्थानीय निवासी' की परिभाषा, जो बिहार में प्रचलित परिभाषा पर आधारित है, की भी समीक्षा की गई।
4. राज्य सरकार द्वारा सभी पहलुओं की सम्यक् समीक्षा एवं समुचित विचारोपरान्त, झारखंड राज्य में 'स्थानीय निवासी' की परिभाषा निम्न रूप से निरूपित करने का निर्णय लिया गया है जो मुख्य रूप से मध्य प्रदेश में लागू नीति पर आधारित है। इसके तहत उसी व्यक्ति को स्थानीय निवासी माना जायेगा, जो:
 - (i) झारखंड में पैदा हुआ हो, अथवा
 - (ii) (क) वह, अथवा
(ख) उसके पालकों (Parents) में से कोई, अथवा
(ग) उसके पालकों (Parents) में से कोई जीवित न हो तो उसका वैध अमिभावक (गार्जियन)
झारखंड में निरंतर कम-से-कम 15 वर्ष से रह रहा हो, अथवा
 - (iii) उसके पालकों (Parents) में से कोई भी :-
 - (क) राज्य शासन का सेवारत या सेवानिवृत्त कर्मचारी हों, अथवा
 - (ख) जिनके पालकों (Parents) में से कोई भी भारत सरकार का कर्मचारी हो, और प्रतिनियुक्ति पर झारखंड राज्य में या झारखंड में स्थित भारत सरकार द्वारा संचालित उपक्रमों/संस्थानों का कर्मचारी हो, अथवा
 - (iv) (क) वह स्वयं, अथवा
(ख) उसके पालकों (Parents) में से कोई भी झारखंड में पिछले 5 वर्षों से कोई अचल सम्पत्ति, उद्योग अथवा व्यवसाय रखता हो,
 - (v) परन्तु, उपरोक्त के अतिरिक्त :-
 - (अ) उसने अपनी शिक्षा झारखंड के किसी भी शिक्षण संस्थान में कम-से-कम 7 वर्षों तक प्राप्त की हो, अथवा
 - (ब) उसने झारखंड में स्थित किसी भी शिक्षण संस्थान में निम्नलिखित परीक्षाएँ उत्तीर्ण की हों, अर्थात् :
 - (vi) यदि संस्थान में प्रवेश के लिए न्यूनतम शैक्षणिक योग्यता मान्यता प्राप्त विश्वविद्यालय की स्नातक उपाधि निर्धारित की गयी हो, तो उच्चतर माध्यमिक परीक्षा,
 - (vii) यदि किसी संस्थान में प्रवेश के लिए न्यूनतम शैक्षणिक योग्यता किसी भी विश्वविद्यालय या बोर्ड की इंटरमीडिएट, हायर सेकेण्डरी या कोई और समकक्ष परीक्षा निर्धारित की गयी हो, तो आठवीं कक्षा की परीक्षा
 - (viii) अन्य मामलों में चौथी कक्षा की परीक्षा,
 - (ix) इसके अतिरिक्त झारखंड को आवंटित अखिल भारतीय सेवाओं के अधिकारियों की संतान एवं उनकी पत्नी प्रदेश की स्थानीय निवासी माने जायेंगे।
 - (x) राज्य सरकार द्वारा निर्धारित झारखंड के स्थानीय निवासी की परिभाषा के अंतर्गत आने वाले व्यक्तियों की पत्नी को भी प्रदेश का स्थानीय निवासी माना जायेगा।
 - (xi) छात्र का पिता यदि मूल निवासी की परिभाषा के अंतर्गत आता है और यदि वह सैनिक सेवा के कारण झारखंड में पदस्थापित नहीं हो सका है तो उसके पुत्र/पुत्री को झारखंड का मूल निवासी माना जायेगा, भले ही उसने राज्य के किसी भी शिक्षण संस्थान में शिक्षा प्राप्त नहीं की हो। यह सुविधा केवल सैनिक सेवा के अधिकारियों/कर्मचारियों को उपलब्ध होगी।
 - (xii) भूतपूर्व सैनिकों के बच्चों के लिए व्यवसायिक कॉलेजों/संस्थानों में प्रवेश हेतु मूल निवासी प्रमाण-पत्र में छूट अनुमान्य होगा।
 - (xiii) कश्मीर से आये हुए विस्थापित परिवारों की कठिनाइयों को ध्यान में रखते हुए उन प्रयोजनों के लिए जिनके संबंध में झारखंड के मूल निवासी होने की शर्त की पुष्टि होनी चाहिए, उससे इन परिवारों को मुक्त रखा जायेगा।
 - (xiv) जिसके पालकों (Parents) में से कोई झारखंड में शरणार्थी के रूप में पंजीकृत हों,
 - (xv) झारखंड के माननीय सांसदों/पूर्व सांसदों/विधायकों/पूर्व विधायक/पूर्व पार्षद एवं बिहार पुनर्गठन अधिनियम, 2000 के आलोक में झारखंड राज्य के पार्षदों के पुत्र/पुत्रियाँ हों।

5. शिक्षण संस्थानों में नामांकन हेतु 'स्थानीय निवासी' प्रमाण-पत्र उन्हीं आवेदकों को जारी किया जायेगा जो किसी अन्य राज्य के 'स्थानीय निवासी' प्रमाण-पत्र से आच्छादित न हों।

6. झारखंड स्थित तकनीकी/व्यवसायिक शिक्षण संस्थानों में दाखिला के लिए पूर्व में जो भी निर्णय अथवा नीति लागू है वह आलोच्य संकल्प के निर्गत होने की तिथि से स्वतः निरस्त समझा जायेगा। यह संकल्प विशेष रूप से झारखंड संयुक्त प्रवेश प्रतियोगिता परीक्षा पर्वद्वारा घोषित आवासीय श्रेणी संबंधी न्यूनतम योग्यता के परिप्रेक्ष्य में संगत होगा, परन्तु यदि झारखंड संयुक्त प्रवेश प्रतियोगिता परीक्षा पर्वद्वारा पूर्व में निर्गत कर दिया गया हो और आवेदन पत्र प्राप्त कर परीक्षा की कार्यवाही शुरू कर दी गयी हो तो वह इस नीति से प्रभावित नहीं होगा।
