Method of recruitment:- On contract basis.

Qualification & Experience:- Graduation in Commerce having the knowledge of Tally with one-year work experience.

Desirable: Candidates having knowledge of latest accounting packages, maintaining files, processing and putting up of the office notes, drafting skills, service rules and regulations of Central Govt./Autonomous Bodies would be preferred.
