1. BPCL Overview

- I. **Bharat Petroleum Corporation Limited (BPCL)** is a Fortune Global 500 (rank of 280 in 2015) oil refining, exploration and marketing Public Sector Undertaking Company with Navratna status.
- II. BPCL is considered to be a pioneer in Indian petroleum industry with various path-breaking initiatives such as Pure for Sure campaign, Petro card, Fleet card etc. BPCL is also one of the foremost organizations to implement ERP successfully across its business domain. This has helped to centralize data and subsequent analysis to meet the challenging market scenario and is still termed as a landmark in the sector. BPCL is a member of the elite group, which SAP consults for further improvements in its Oil & Gas related products.
- III. BPCL has network of underground cross country pipelines across the length and breadth of the country. The approximate length of BPCL pipelines is 2,200 kms.
- IV. BPCL intends to undertake surveillance of its pipeline network through Unmanned Aerial Vehicle/Shuttle (UAV/UAS) to further enhance the surveillance system in inaccessible terrains and vulnerable areas. Initially it is proposed to explore the possibility of this technology for a small section at a location / zone which will be decided at a later stage.
- V. As we understand unmanned aerial vehicles/shuttle (UAV/UAS) equipped with cameras and sensors, infrared or laser pulses are proving to be beneficial for surveillance of pipelines. Moving forward it is required to extract more value from this exercise by storing this data, analyzing, and maintaining historical records for comparison.
- VI. Through this Expression of Interest, BPCL intends to collect information with regard to the "Best Value for Money" option, meeting all the functional / performance requirements of UAV/UAS surveillance system required for BPCL cross country pipeline network.

2. Expectation from the proposal

- I. The applicant party could be either UAV/UAS manufacturer (or) their sole authorized distributor / channelizing agency who has carried out surveillance in the past using UAV/UAS.
- II. The applicant party shall submit the technical specification/details of the Unmanned Aerial Vehicle/Shuttle (UAV/UAS) being proposed and should showcase how effectively it can be deployed for the job of pipeline surveillance.
- III. The surveillance of the pipeline Right of User will consist of surveying of pipeline (partial or full) using the UAV/UAS during day time with suitable daylight camera and in night time with suitable infrared camera. Applicant party to provide details of the cameras which shall be used for both day and night operations which shall prove effective for pipeline surveillance.
- IV. The applicant party shall provide us with the detailed information about usage of the UAV/UAS and the permissions and approvals which are required to be taken from various statutory bodies for flying the UAV/UAS. The vendor shall also throw light on the restricted areas for the flying of the UAV/UAS like the no flying zone etc. Initially it is proposed to explore the possibility of this technology for a small section at a location / zone which will be decided at a later stage.
- V. The applicant part shall guide and provide us a clear policy regarding the usage of the UAV/UAS for the surveillance and also clearly come out with the associated risk of flying an UAV/UAS.
- VI. The deployed UAV/UAS system shall have both the provision of flying autonomously as well as piloted remotely from the ground.
- VII. Applicant party shall provide real time colour video image as well as photographs of the survey in a Laptop/Hand Held Device at the ground control station during the flight of the UAV/UAS. The collected images and videos should be able to detect various observations like sabotage, illegal tapping, excavations and construction work and possible leaks etc. and generate the inspection report.
- VIII. To create a tamper proof record of the events being covered by each camera for post event analysis, applicant party to confirm that all the recordings will be admissible as evidence in any court of law.
 - IX. The system should have advanced video analytics available. e.g. zooming facilities etc.
 - X. The system should be remotely available over internet to any authorized BPCL user.
 - XI. User should be able to easily control the UAV/UAS through a user friendly interface. Viewing live and recorded videos, export movie evidence should be at ease.

- XII. The system supplied should be scalable for future additions of cameras & network switches & storage capacity & based on open standards.
- XIII. The system should have adequate inbuilt tamperproof measures and should generate alarms/alerts.

3. EOI DOCUMENT

- I. Applicant parties need to download this Expression of Interest (EOI) document from BPCL website or our e-tendering website. For participation in this EOI, applicant parties should have a legally valid digital certificate (Class II and above).
- II. All prospective applicant parties are requested enroll onto our e-tendering platform https://bpcleproc.in/ maintained by M/s. E-procurement Technologies Ltd, our authorized Service Provider for E-tendering.
- III. Upon logging in to the e-procurement website, applicant parties can download the bid documents and shall thoroughly go through the same. All documents required for the bid, shall be uploaded on the appropriate place in the E-Procurement web site, digitally signed. No physical scanned documents need to be uploaded except those specifically indicated.

INSTRUCTIONS TO BIDDERS ON E-TENDERING

1.0 GUIDELINE FOR E-PROCUREMENT SYSTEM:

Bharat Petroleum Corporation Ltd. has gone for online submission of bid through e-procurement system on https://bpcleproc.in. Bidders are advised to read the Instructions for participating in the electronic tenders directly through internet (Bid Submission Manuals are available on the above mentioned e-procurement site).

To participate on tenders hosted by BPCL on e-procurement site, bidders are required to have a digital certificate and do "Enrollment" (Register on site) by creating one User Id on the above site.

Bidders shall make their own arrangement for e-bidding. The Un-priced Technical Bids along with all the copies of documents should be submitted in e-form only through BPCL e-Procurement system. Before the bid is uploaded, the bid comprising of all attached documents should be digitally signed using digital signatures issued by an acceptable Certifying Authority (CA) in accordance with the Indian IT Act 2000. If any modifications are required to be made to a document after attaching digital signatures, the digital signature shall again be attached to the modified documents before uploading the same.

Late and delayed Bids / Offers after due date / time shall not be permitted in E-procurement system. However if bidder intends to change the bid already entered may change / revise the same on or before the last date and time of submission deadline. No bid can be submitted after the last date and time of submission has reached. The system time (IST) that will be displayed on e-Procurement web page shall be the time and no other time shall be taken into cognizance.
