On appointment, the candidate shall be governed by the ITBPF Act and Rules and other Rules applicable from time to time. #### 5. ELIGIBILITY CONDITIONS:-

- (1) Age 18 to 23 years (Cut off date for determining the age will be 31.10.2016)
  - (a) Upper age limit is relaxable for SC/ST by five (5) years and for OBC by three (3) years.
  - (b) Upper age limit is relaxable up to 05 years for Departmental candidates with three years continuous service and in addition 5 years age relaxation for Scheduled Caste or Scheduled Tribe and 3 years for Other Backward Classes who compete along with candidates from open recruitment.

#### 9. APPLICATION FEE

The candidates belonging to General and OBC category shall be required to pay Rs 100/- (Non refundable) as application fee in form of Indian Postal Order (IPO) in favour of the DIG, BTC, ITBP for each post. Number and date of IPO should be mentioned on application form at earmarked space.

#### 11. <u>SELECTION PROCESS:-</u>

The eligible candidates shall be issued Admit cards to appear in recruitment test. The date and place of recruitment test will be indicated in Admit card. Candidates will have to undergo the following Tests:-

- a) Checking of documents:- The candidates will required to produce the original and attested photocopies of the documents related to his/her education qualification, proof of Date of birth, etc as mentioned in Para-10 above and also submit Sports achievement Certificates of the Sports discipline as per para-5(3). The original documents will be returned to the candidate on the spot after verification.
- b) Physical Standard Test (PST) Candidates found eligible in documentation will be screened for height, chest (chest measurement for male candidates only) and weight measurements by the Board. Those who do not meet the required physical measurements shall be eliminated at this stage.
- c) Physical Endurance Test (PET):- Candidates who qualify in documentation and PST will undergo 01 mile race to be completed within 06 minutes 30 seconds (for male) and within 08 minutes 30 seconds (for female). No marks will be awarded for this test and PET will be qualifying in nature. The departmental candidates who have qualified Physical Test at the time of their appointment in the Force are not required to appear in the Race event.
- **d) Trial Test:-** Trial Test in respect of game for which a candidate has applied shall be taken to evaluate his/her performance of respective discipline/event by the Recruitment Board.
- e) Merit List Merit list will be drawn on the basis of marks obtained in the Trial Test, which shall include Sports achievements, performance in Trial Test and Technical opinion of the Trial Test Board.

In case of tie in marks, the candidate with higher marks in Sports achievements will be higher in merit. In case tie continues candidate younger in age will be higher in the merit. In case tie continues candidate whose name comes first in the alphabetic order (English) will be kept higher in the merit list

12. <u>Detailed Medical Examination (DME)</u>:- Candidates shortlisted in **order of merit** in each discipline/event will be put through Detailed Medical Examination to assess their fitness as per existing policy.

#### 13. Appeal against Detailed Medical Examination:-

- A candidate declared unfit in detailed medical examination, if not satisfied with the findings of the Medical Officer, can submit an <u>appeal for his Re-Medical Examination (RME) with a duly filled</u> <u>Medical certificate as per Annexure-VI.</u>
- ii) The medical certificate shall not be taken into consideration unless it contains a note by the medical practitioner concerned to the effect that it has been given in full knowledge of the fact that the candidate has already been rejected as unfit for appointment in ITBP by a Medical Officer.
- iii) The appeal shall also not be taken into consideration unless it contains:
  - a) Medical Re-Examination Fee of Rs. 25/- in form of Indian Postal Order in the name of the IG, Training Zone, ITB Police Force, Block No. 4, CGO Complex, Lodhi Road, New Delhi-110003.
  - b) Rejection slip (in original) issued by the Presiding Officer during detailed medical examination.

- c) Self addressed Envelop with Rs. 5/- postage stamp affixed on it. Candidates are advised to affix stamp of Rs. 25/- or Rs. 40/-, if they desire that Call Letter for R.M.E. is to be sent by Registered post or speed post.
