At the time of reporting, the candidates must ensure that they fulfill the eligibility criteria in respect of age, category (SC/ST/OBC/PWD), and educational qualification etc. as stipulated in the advertisement/notification for CWE PO/MT-IV by IBPS and produce original testimonials / documents for verification. Reserved category candidates are required to submit the Caste/PWD certificate as per Govt. of India guidelines (Specimen also available on Bank's Website in the Recruitment section).

At the time of reporting at **Human Resource Development Institute, Noida on 24.04.2016**, the candidates will have to produce the following documents in original for verification along with a set of self attested photocopies:-

- a. Educational certificates / testimonials (birth certificate / mark sheets/ pass certificates/ degree certificate etc.)
- b. The enclosed Employment Form duly filled in your own handwriting along with self attested photograph affixed at the appropriate place.
- c. The enclosed Secrecy & Fidelity Bond duly filled in.
- d. The enclosed Attestation Form duly filled in with all details therein.
- e. Original Scheduled Caste/Scheduled Tribe/Other Backward Class/Disability Certificate along with attested photocopy thereof, for verification, if applicable. For candidates belonging to OBC category, the certificate *must have been issued on or after 01.07.2014* and must specify that the candidate *does not belong to Creamy layer* section excluded from the benefits of reservation for OBCs. Please note that respective caste certificate is as per the performa prescribed by the Government of India and should have been issued by the competent authority. It is pertinent to note that the caste mentioned in the certificate produced should tally letter by letter with that of the caste as mentioned in the Central Government list / notification.
- f. If employed, a clean relieving certificate from your present employer stating therein that there is nothing against you.
- g. Medical certificate of your fitness from a Registered Medical Practitioner not below the rank of M.B.B.S. (Format available on Bank's website)
- h. Three additional passport size photographs of your frontal pose duly self attested at the back thereof.

The Caste/Tribe/Community certificate issued by the following authorities in the prescribed format for SCs/STs/OBCs will only be accepted as proof in support of a candidate's claim as belonging to the Scheduled Caste or Scheduled Tribe or Other Backward Class:

- District Magistrate/Additional District Magistrate/Collector /Deputy Commissioner/Additional Deputy Commissioner/ Deputy Collector/ 1st Class Stipendiary Magistrate/Sub Divisional Magistrate/Taluka Magistrate/Executive Magistrate/Extra Assistant Commissioner.
- ii. Chief Presidency Magistrate/ Additional Chief Presidency Magistrate/Presidency Magistrate;
- iii. Revenue Officer not below the rank of Tehsildar; and



iv. Sub-Divisional Officer of the area where the candidate and/or his family normally resides.

Those candidates who fail to produce required original documents will not be allowed to join the Bank.

In case it is detected at any stage, either at the time of verification of documents or even after appointment in the Bank, that any candidate does not fulfill the eligibility norms and/or has furnished any incorrect/false information/certificates/documents or has suppressed any material fact(s), his/her services are liable to be summarily terminated.

The candidates are informed that their candidature may be cancelled in case it is found that they do not satisfy the eligibility criteria stipulated in the notification.

The appointment letters to the candidates are being dispatched separately.

NOTE: As per the judgment of Hon'ble Supreme Court dated 17.03.2015, in the writ petition (Civil) No. 274 of 2014, Ram Singh & Others Vs. Union of India, the Govt. of India notification bearing no. 63 dated 04.03.2014 including Jats in the Central List of Other Backward Classes for the states of Bihar, Gujarat, Haryana, Himachal Pradesh, Madhya Pradesh, NCT of Delhi, Bharatpur and Dhaulpur Districts of Rajasthan, Uttar Pradesh and Uttarakhand is set aside and quashed. Accordingly, candidates belonging to the Other Backward Classes (OBC) Jat category covered under the said notification have not been given the benefit of the reservation. Bank has taken utmost care in compiling the above list. However, In case of any inadvertent errors the Bank reserves the right to rectify the same.
